## ➤ Uniform Policy

Dress Code Guidelines are established to promote a standard of appearance which enhances the learning environment while allowing for the reasonable comfort of all students.

Uniforms are expected to be worn on a daily basis. Please note that hats, bandanas, scarves, and other inappropriate head gear, including hooded garments, are not part of the school uniform and should not be worn. It is the responsibility of the parent/guardian to purchase the proper school uniform for his/her child. If a student moves to another school that has a different school uniform, any purchase of a school uniform for the new school will also be the responsibility of the parent/guardian. **(EBOE Policy Code 5132, 5133)**

### PHYSICAL EDUCATION

- T-Shirt\* or Sweatshirt\*
- Shorts\* or Sweatpants\*
- Sneakers

If students are not prepared with the proper attire for Physical Education, they must be in full uniform and will, ultimately, lose credit for class that day.

NOTE: Grade 9-12 students must bring their gym uniform to change for physical education class.

\*All items marked with an asterisk must have the LEAP logo (neighborhood school emblem) or the school's logo.

\*\*Khaki shorts must be knee high and only worn between May 15<sup>th</sup> and October 1<sup>st</sup>.

Please note that this is a standard uniform list for most neighborhood schools. The uniform policy is the same districtwide but may vary in color depending on the school/academy.

As previously noted, students must be in full uniform daily and at all times; this means during arrival and dismissal, while transitioning in the hallways, and while in the cafeteria. All students, even those who have Gym 1<sup>st</sup> period, must report to school in full uniform. Jackets and other outerwear must be left in lockers and may not be carried throughout the school day. Although students will be able to remove their blazers while in the classroom, it must be draped across the back of the chair and not placed on tables, on shelves or in bookbags.

Uniform infractions will result in suspension pending a parent conference and an afterschool detention or a Saturday detention. Students who report to school without a full uniform will have to notify a parent/guardian in order to have the uniform brought to school. Students will remain near the main entrance or in the nurse's office until contact is made with a parent/guardian in regards to the uniform. Students will lose attendance credit for missed classes due to uniform infractions.

### ➤ Communication

It is extremely important that we have the most updated phone numbers and home address so that we may contact you in the event of an emergency or to discuss your child's progress. Please be sure to notify both the teacher *and* the main office at any time throughout the course of the school year if there is a change in address and/or a phone number. Open communication between the home and the school is expected and is one of the most pertinent keys to academic success in school.

### ➤ District's Code of Student Conduct

The Board of Education believes that an effective instructional program requires an orderly school environment and that the effectiveness of the educational program is, in part, reflected in the behavior of pupils. The only exceptions to cell phone and/or headphone usage is when a student has written permission from a teacher for a specific assignment or if the student is in the cafeteria during breakfast and/or his/her lunch period. Aside from these two exceptions, cell phone and/or headphone usage cannot be visible and/or used in classrooms/hallways at any other time. If parents/guardians should need to contact students, they may do so by calling the main office at 908-436-6500.

Bluetooth speakers are not allowed in the building and will be confiscated at the school entrance.

If a student receives an infraction and refuses to turn in his/her cell phone or electronic device to a teacher, the student will receive a suspension pending a parent conference and a Saturday detention.

### ➤ Attendance

New Jersey statues require every parent / guardian or other persons having custody and control of a child between the ages of 6 and 16 years to cause such child regularly to attend the public schools of the district. A student must be in attendance for at least 171 of the 180-day school year (95%). In order to be considered to have successfully completed the instructional program requirements of the grade / course to which he/she is assigned, no more than a total of nine (9) absences is allowed. **(EBOE Policy Code 5113)**

Students are expected to arrive to school on time. Consequences for tardiness will include phone conferences with a parent, afterschool detentions, and, possibly, Saturday detentions.

### ➤ Safety and Security

Please note that the safety of our students is of the utmost importance to us. Therefore, please have the proper photo identification readily available for the security guards in order to receive a visitor's pass upon entering the building. An orderly school environment is essential to the success of our learning program.

### ➤ Graduation Requirements

The Elizabeth Board of Education shall award a state-endorsed diploma to acknowledge the successful completion of the requirements for high school graduation. The Elizabeth Board of Education diploma will represent a high standard of curriculum content, instruction, and student learning, thereby ensuring post-secondary readiness for all graduates in the 21st century.

### Academic Requirements:

- Twenty (20) Credits in language arts literacy;
- Twenty (20) Credits in mathematics (including Algebra I, Geometry, Algebra II and higher mathematics);
- Fifteen (15) Credits in social studies (including 10 credits in the history of the United States in satisfaction of N.J.S.A. 18A:35-1 and 2; and 5 credits in world history); and the integration of civics, geography and global content in all course offerings;
- Two-and-a-Half (2.5) Credits in financial literacy;
- Twenty (20) Credits in science, including at least five credits in laboratory biology/life science; an additional five credits in a laboratory/inquiry-based science course including chemistry, environmental science, or physics; and third and fourth laboratory/inquiry-based science courses.
- Sixteen (16) Credits in physical education, health, and safety during each year of enrollment, as required by N.J.S.A. 18A: 35-5, 7 and 8;
- Five (5) Credits in visual and performing arts;
- Five (5) Credits in 21st century life and careers, or career-technical education;
- Ten (10) Credits in World Languages;
- Technology literacy, consistent with the New Jersey Student Learning Standards, integrated throughout the curriculum;
- All courses shall be taught at the college preparatory, honors, or advanced placement levels;
- Students enrolled in Advanced Placement (AP) courses are required to take the designated AP examination administered by the College Board. If the student does not take the AP exam, the student's AP course designation must be changed from Advanced Placement to Honors and the modification must be recorded in the student's records and transcript; and
- Effective beginning with the high school graduating class of 2014, and all subsequent graduating classes, students must take the SAT®, ACT®, or equivalent college entrance exam.

### ➤ **Freshmen Orientation**

***Our Freshmen Orientation will be held on Thursday, August 22<sup>nd</sup>, 2019 from 10:00 a.m. to 12:00 p.m.*** At the Freshmen Orientation, students and parents will have an opportunity to learn more about Bollwage Finance. Students must have a parent/guardian present and parents must have completed the re-registration form and signed the acceptable use policy in order for students to receive their laptop.
