Dear Parents/Guardians and Students,

FIRST DAY OF SCHOOL / ARRIVAL AND DISMISSAL PROCEDURES

The 2023–2024 school year will begin on Friday, September 8th, 2023. Instruction will be conducted during the hours of 8:20 a.m. to 3:00 p.m. In order to help facilitate both a smooth and orderly mode of transition during the times of arrival and dismissal, please adhere to the following safety procedures:

The classroom assignment for your child can be found on the envelope for this document. The school will begin arrival procedures at 7:50 a.m. We ask that all students report on time to school by 8:20 a.m. and that they enter through their assigned door as indicated below:

*Only Kindergarten parents (Homerooms K-012, K-013, K-102, & K-103) have the option of dropping		
off their child at the classroom door at 8:20 a.m. Any time before 8:20 a.m. students must be dropped		
off at the Main Entrance.		

Any student arriving after 8:20 a.m. will be marked tardy and must enter through the main doors on First Avenue.

Dismissal Procedures: Dismissal will begin at 3:00 p.m. and students should be picked up at the designated areas listed below:

Grades K and Homeroom 1-101	Exterior Classroom Doors
Homerooms 1-010 and 1-011	Side Door on First Avenue
Homerooms 1-008, 2-003, 3-001, and 3-100	Main Office Doors (Playground Area)
Homerooms 2-004, 2-006, 2-007, 3-005, and 3-009	Main Entrance on First Avenue
Grades 4 - 5	Cafeteria Doors (Playground Area)
Grades 6 - 8	Dismissed onto Elizabeth Avenue

Note: We are a peanut-free school so food items containing peanuts will not be allowed in school. In addition, soda, energy drinks, and any glass beverages are not permitted.

School Supplies: Visit our school website https://www.epsnj.org/school25 to access our school supply lists.

Cell Phones: Cell phones must remain off and in a student's backpack or it will be taken and sent to the office for a parent to pick up. Additionally, students will not be allowed to wear any Bluetooth listening devices during the school day. Bluetooth devices must remain in their backpacks or will be taken and sent to the office for a parent to pick up.

Sweaters: Only school uniform sweaters and sweatshirts can be worn in school. NO other sweaters or hoodies will be allowed to be worn during the school day.

LABELS: To help us identify all our students on the first day of school, we have placed a label in this envelope. We ask that you write your child's first and last name on the label. All students should wear the label on the first day of school. Also, please remember to label all your child's belongings including their uniform sweaters.

EPS SCHOOL CALENDAR

We ask that you guide and support your child's learning by ensuring that he/she attends school daily, arrives on time, and is ready for the day's learning experience.

POWERSCHOOL PARENT PORTAL INSTRUCTIONS

PowerSchool is an electronic management system that is utilized by the Elizabeth Public Schools in order to collect, store, and maintain pertinent student data and records. The application provides parents with real-time access to information that pertains to a student's schedule, attendance, grades, and academic progress; it also

offers a convenient and accommodating way for both parents and teachers to communicate as needed. Therefore, everyone stays connected. Schedules for the upcoming 2023-2024 school year will be available to view on PowerSchool on *Wednesday*, *August 30th*.

NEW AND RETURNING PARENTS TO EPS

Parents of new students must request a new account in order to input all of the information required to navigate the PowerSchool Parent Portal. Parents of existing students will need to log in, input, and update any changed information that has occurred for their child.

You will then be directed to complete an online contact form. After clicking the *Save* and *Done* buttons at the bottom, your request will be submitted and someone from the school will be in contact with you as soon as possible.

UNIFORM POLICY

The intended purpose for the EPS dress code is to promote a positive self-image and to enhance school pride amongst our students. Health, safety, and educational well-being are the primary objectives for the dress code with the goal of fostering an environment that is conducive to discipline as well as to education. School uniforms are expected to be worn on a daily basis.

Parents, we are asking for both your cooperation as well as your support regarding your child's adherence to the uniform policy. ELECTRONIC DEVICES

For the past few years, our school has operated as a 1:1 technology school; and as a result, all students will continue to utilize a <u>laptop computer</u> for their daily classroom instruction. Students should make every effort to take excellent care of their <u>laptops</u> throughout the school year, as this is a very special privilege. Our 1:1 technology implementation will continue to ensure that our students attain the competitive standards that are needed to foster both college and career readiness. All students are required to bring their charged laptops and power cords to school daily.

All new students to the district will receive their laptop during the first week of school.

NEW AND EXISTING PARENT INSTRUCTIONS

Open communication between the home and the school is expected and is one of the more pertinent keys to academic success in school.

Our Notification system enables staff members to contact parents through email, text, and through verbal messages recorded on the phone. Through this system, parents are immediately alerted of urgent information, major events, and/or upcoming dates. To ensure that this system will continue to operate in a highly effective manner, it is very important that we have *the most current and accurate information on file for each and every student*.

IMMUNIZATION REQUIREMENTS

The state of New Jersey has mandated that all children born after January 1st, 1997 and enrolled in Grade Six, will be required to receive a booster dose of the diphtheria, tetanus and pertussis vaccine (Tdap) as well as one dose of meningococcal vaccine. Documentation that your child has received the required sixth grade immunizations must be turned into the school nurse no later than *Friday*, *September* 8th, 2023.

Students entering 6th grade with birthdays on or after *Friday*, *September* 8th, 2023 must provide written confirmation from your child's healthcare provider of the vaccination appointment. This appointment should be within two weeks of your child turning 11 years of age. The immunization record must be submitted immediately following the appointment. The Elizabeth Public School District is compelled by law to ensure that all students receive their required immunizations.

<u>Children who do not meet immunization requirements or do not have documentation of a scheduled appointment within two weeks of turning 11 years of age will be excluded from school beginning the first school day.</u>

TRANSPORTATION

Transportation will be available for the following students:

- Elementary students who live more than 2.0 miles from their school
- High school students who live more than 2.5 miles from their school
- Students whose IEP include transportation services
