Students of Terence C. Reilly,

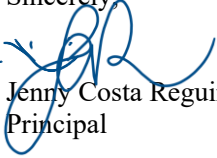

Student Responsibilities

Academics

All students in the gifted and talented program are responsible for maintaining satisfactory levels of academic performance. This is demonstrated by completing classwork and homework assignments and achieving grades of 70 or above in all classes. The Gifted and Talented Program adheres to all requirements for promotion and retention adopted by the Elizabeth Board of Education. **As such, any student whose final grade in Language Arts Literacy or Mathematics falls below 70, will be removed from the Gifted and Talented Program, referred to summer school classes, and may face retention in his/her current grade level.** Students' grades are accessible via the PowerSchool system at www.epsnj.org. It is important that you communicate on a regular basis with your child's teacher (s).

Attendance

Terence C. Reilly School No. 7 operates on a regular school day from 8:20 AM to 3:00 PM. Students are responsible for maintaining satisfactory attendance.

Students may be removed from the Gifted and Talented Program for:

- Fifteen instances of arriving to school late (i.e. after **8:25 AM**) and/or early dismissal (before **3:00 PM**); students arriving late due to school bus delays will not be penalized.
- Unexcused absences of ten consecutive days. Any student absent for three or more days, or being excused from physical education for three or more days, must submit a physician's note to his/her homeroom teacher.
- Please note that as part of the promotion/retention policy students will be asked to attend summer school if the attendance/tardiness policy is not followed.

Please note the following procedures for student absences and tardiness:

Absences

Days 1-4	Student absences will be monitored by the school. <i>In the event that a student is absent for three or more days in one marking period, the school will contact the student's parent(s) to arrange an attendance review meeting.</i>
Days 5-9	If a student is absent between five and nine days, the school will contact the student's parent(s) to arrange an attendance review meeting. If necessary, an attendance officer will visit the student's home to review pertinent attendance data with parents.
Day 10	Upon the tenth student absence, the school district will make a mandatory referral to the New Jersey Administrative Office of the Courts. The student will also be in danger of being removed from the Gifted and Talented Program.
Day 12	A letter will be sent home informing you that your child will lose his/her place at Terence C. Reilly School No. 7 upon their fifteenth day of absence. The attendance officer will make a visit to your home to ensure you understand your child must report to school or they will be transferred to their neighborhood school. The Attendance Task Force will update and review case.
Day 15	Child will be transferred to his/her neighborhood school.

Tardiness/Early Dismissal

Day 5	Student tardiness will be monitored by the school. A warning letter will be sent to parents by the school.
Day 10	The school will contact the student's parent(s) to arrange an attendance review meeting. If necessary, an attendance officer will visit the student's home to review pertinent attendance data with parents.
Day 12	A second warning letter will be sent to parents by the school. The student will be in danger of being removed from the Gifted and Talented Program.
Day 15	Child will be transferred to his/her neighborhood school.

Discipline

Students at Terence C. Reilly School No. 7 are expected to demonstrate their good judgment throughout their school experience. Our school adheres to all discipline policies adopted by the Elizabeth Board of Education and prohibits behavior in the following areas:

- Visiting lockers at unscheduled times
- Gum chewing and Candy
- Excessive talking in class
- Lateness to class
- Cutting class and/or leaving class or lunchroom without permission
- Disrespectful, defiant, or disruptive behavior
- Cheating, forgery, or plagiarism—Academic integrity/dishonesty violations
- Fighting
- Bullying
- Defacing school property
- Assault on a student or teacher
- Cutting teacher detention
- Using obscenities, profanity, and/or inappropriate language or gestures
- Dress code infractions- students must be in full school mandatory uniform every single day.
- Possession of any items deemed inappropriate for school
- Inappropriate behavior on the bus
- Inappropriate contact and/or behavior
- Harassment and/or bullying of any kind
- Inappropriate use of school technology-which includes inappropriate use of emails, sharing passwords, non-school appropriate conversations, destructions of devices, and loss of devices.
- Use of students' cellular phones and other personal electronics inside the school, including before/after school hours (*please note that cellular phones and personal electronics will be confiscated if found in use and will only be returned to parents in-person*)
- Vandalism-vandalism of any kind will result in student probation and/or removal of the G&T Program.

Stipulations of Termination from the Gifted and Talented Program**ACADEMICS**

- All students must maintain satisfactory levels of academic performance. This is demonstrated by completing classwork and homework assignments and achieving grades of 70 and above in all classes.
- In an incident where students fail Language Arts and Math for the majority of the school year with the proper Intervention and Referral Services process followed through; students will be required to attend the district's Summer Retention Program. Upon which, students will be terminated from the Gifted and Talented Program.
- All students will be required to take care of their School issued Technology Devices. These devices are to be used for schoolwork and school usage only. Students will be responsible for bringing their devices back and forth from home to school. Devices should be fully charged (overnight) and be ready for daily instruction and learning the next day.

BEHAVIOR

- In an incident where a student's behavior has had a negative impact upon the school or to others, an investigation will take place. Consequences will be rendered, decided upon by administration, with consideration of the action(s). Behavioral Interventions may be put into place for a determined period of time. Students will have verbal and written warnings to parents regarding their probation period from being terminated from the Gifted and Talented Program. If there is no progress or change in their behavior after actions have been rendered, students' placement in the Gifted and Talented program will be terminated.
- In an incident where a student assaults another student(s) or faculty member with clear intent and motivation, the student will be terminated from the Gifted and Talented program immediately.

ATTENDANCE

- All students must maintain a satisfactory level of attendance.
- Fifteen instances of arriving to school late and/or early dismissals may result in termination from the Gifted and Talented Program.
- Unexcused absences of ten days may result in termination from the Gifted and Talented Program.

DRESS CODE

- **All students must** attend school in the appropriate uniform as outlined in the student handbook with no exceptions.
- **Six** instances of student failure to wear the full uniform may result in termination from the Gifted and Talented Program.

The Gifted and Talented Program requires all students to wear an appropriate uniform. **Please note that six instances of student failure to wear the full school uniform may result in removal from the Gifted and Talented Program.** Parents/guardians are responsible for replacement or additional uniform items. Students are encouraged to mark their names on the tags of polos, cardigans, and physical education uniforms (t-shirts, sweatshirts, sweatpants, and mesh shorts).

Physical Education Uniforms

- Blue Tee Shirt or Blue Sweatshirt with Gifted and Talented Program Emblem
 - Navy Mesh Shorts or Navy-Blue Sweatpants with Gifted and Talented Program Emblem
 - Sneakers (any color) can be worn on GYM DAYS ONLY.**
 - Students in **Grades 2-8** may wear their gym uniforms to school on physical education days only.
- Students must be in full uniforms on the days they do not have gym.**

Dress Code for Terence C. Reilly School #7

The purpose of a dress code is to establish limits on any extremes in students' appearance, promote a positive image, and to sustain a safe and friendly school environment that accepts all students.

- Clothing that is cut off, tattered, torn or has holes must be repaired before it is worn to school.
- Pants and skorts should be worn around the waist and not lowered, rolled down or under the waistline.
- Only school approved cardigans with the G/T logo should be worn during school hours and for other announced occasions. **No Fleece are required-those can be worn outdoors only.**
- Shoes must be black leather, or man-made leather dress shoes that can be tied, buckled, velcroed or slipped-on. Shoes **CAN NOT** resemble sneakers. If medically required for another foot apparel, a **signed note** from the student's doctor **MUST** state the **time period** with an **ending date**.
- For special Celebratory Events or Recognition Days, students are **ONLY** allowed to wear accessories or special clothing pertaining to that day **OVER** their TCR uniform, and it is not to be substituted for the TCR uniform.
- NO** tight-fitting clothing. **NO** gap between top and pants, skort or skirts. Even an incidental gap from bending, stretching or sitting is unacceptable.
- NO** Boots, TOMS®, Vans®, corduroys, cargo pants, or Jeggings which are not part of the school uniform.
- NO** hats or outerwear such as winter coats or heavy jackets may be worn or carried during the school day except for entering and leaving the school.
- NO** bandanas, sweatbands, or inappropriate head attire.
- NO** sunglasses, unless medically approved by a physician.

Student Rights

As a student at Terence C. Reilly School No. 7, you have the right to:

- Feel safe
- Receive quarterly and semi-quarterly reports of your academic progress
- Be held to high academic standards
- Be responsible for following our school's code of conduct and core values.

Student Food and Allergy Safety**Food Policy**

- Students may consume food in the cafeteria only.
- Students who bring in their own home prepared lunch must bring their bagged lunch or lunchbox in their bookbags before entering school in the morning.
- After 8:20 a.m. and/or arriving to school in the morning, with the exception of a home-prepared bagged lunch, students may not bring in or receive outside food, including fast-foods (for examples... Dunkin Donuts, McDonalds, any food delivered by Door Dash, Uber Eats, or dropped off at the school, etc.), open bottles of any kind, glass bottles, sodas, and bulk food. Any food or drinks of this kind (including from Dunkin Donuts) must be discarded at the door.
- Terence C. Reilly is a NUT FREE School. Please refrain from sending and/or bringing to school any food items that contain any kind of nuts.
- Terence C. Reilly is a Healthy Alliance School. Please refrain from sending and/or bringing to school any types of candy, cakes, cupcakes, and sugary drinks.
- **No birthday party celebrations** of any kind are permitted in the school or classrooms as in accordance with our healthy alliance policy and district food safety and nutrition policy.

Technology/Laptop Reminders:

Please ensure that your child brings their laptop charger to school each day. Students who come to school without a charged laptop will need to borrow a charger from another classmate or be without a charged laptop. There are no extra chargers or laptops in the building. If the borrowed charger is misplaced, the lender of that charger is responsible for the cost of replacement as chargers and laptops are assigned to one user.

In accordance with the School District's User Acceptable Policy for mobile devices, students are responsible for lost, stolen, or unreturned mobile device accessories, such as chargers. For example, if a charger is broken, the student can get a replacement charger by returning the broken unit to the school technician or hardware department for proper disposal. However, a **fine** of \$37.00 per unit will be charged to the student in case of a lost or stolen charger. Different charges and costs may apply for lost or stolen laptops, and continuously cracked screens or broken laptops.
