We know that you have many questions about how this extended school closure will impact your child(ren); especially our high school students and their credit needs for graduation. We are continuing to work with the New Jersey Department of Education on the development of the guidance given these unprecedented times.

NEW INFORMATION

Starting on Monday, April 27 at 9:00 a.m., students and parents will be able to view K-12 report cards for the third making period on the PowerSchool Parent Portal. Converting to a secure, password-protected online report card system will allow parents and students to get more timely delivery of grades. Please note that the adjusted marking period schedule for this year is as follows: Marking Period 3: February 5 – March 16

Marking Period 4: March 17 – June 15

Phase 2 E-Remote Learning Plan

We have incorporated "Flex Fridays" into our student schedule in order to provide students additional time to complete their weekly assignments. Your child's teachers will continue to provide support during office hours.

I would like to share that the instructional packets are being delivered by mail to your home. Based on the date the packets were delivered to the post office, we anticipated and were optimistic that packets would reach homes in time for students to start Phase 2 of E-Remote Learning on our announced launch date. Unfortunately, with the increased strain on the postal service and delays in mail delivery, it appears that packets have not yet reached all their intended recipients. I will be in contact with our local post office to obtain further updates.
