

GOALS OF ELIZABETH PUBLIC SCHOOLS PREPAREDNESS PLAN

The Elizabeth Public Schools Preparedness Plan was developed utilizing its existing Pandemic Influenza Response Plan.

- During a pandemic outbreak, the Elizabeth Public Schools will implement this plan to achieve the following goals:
 - Limit the exposure of the virus to prevent illness
 - Preserve continuity of essential school functions
 - Minimize educational and social disruption
 - Minimize economic and academic losses

The plan will be coordinated with

- other local response and support agencies' hazard plans and activities
- plans of the City of Elizabeth and State and Federal Partners

TIMELINE FOR CLOSURES

- Whether or not schools will be closed and for how long is impossible to say in advance
- School closings may likely happen during a pandemic event
- Duration of school closings will be
 - Determined at the time of the event
 - Based on characteristics of the pandemic

It is *unlikely* that schools will be closed for less than two (2) weeks and could be closed as long as 12 weeks.

PLANNING ASSUMPTIONS

- Planning assumptions that are being used by the community include:
 - Working closely with local health and emergency services agencies will maximize the health and safety of the school community. Understanding the roles of each agency and their responsibilities will promote coordination and communications.
 - A pandemic will result in the rapid spread of the infection with outbreaks throughout the world. Communities across the state and the country may be impacted simultaneously.
 - There will be a need for heightened global and local surveillance of symptoms and infection rates.
 - Social distancing strategies aimed at reducing the spread of infection such as closing schools, community centers, and other public gathering points and canceling public events may be implemented during a pandemic.
 - The general public, health care partners, response agencies, elected officials and schools will need continuous updates on the status of the pandemic outbreak; the steps local response agencies and the school district are taking to address the incident and steps the public can take to protect themselves.

CONCEPT OF OPERATIONS OVERVIEW

- Union County Division of Health and/or City of Elizabeth Health Officer will be the lead agency in coordinating the local health and medical response to a pandemic outbreak
- Elizabeth Public Schools will maintain increased communications with the Union County Division of Health and/or City of Elizabeth Health Officer, and the New Jersey Department of Education
- Elizabeth Public Schools will provide information to implement recommended procedures that increase health and safety of the school community

ELIZABETH PUBLIC SCHOOLS DISTRICT RESPONSIBILITIES

- Develop capabilities to implement non-medical measures to decrease the spread of disease throughout the school community as guided by the epidemiology of the pandemic and the Union County Division of Health.
- Identify chain of command in case of illness with a minimum of 2 back-ups for key administrators following the District's Emergency Management Plan.
- Develop plans to communicate regularly with individual schools about the status of the situation and provide guidance throughout the duration of the pandemic outbreak.
- Develop and implement pandemic preparedness activities and a business continuity plan aimed at maintaining the provision of educational services and limiting the spread of disease throughout the duration of the pandemic outbreak.
- Review District sick leave policies and make adjustments as necessary to ensure non-punitive policies are in place.
- Review District policies regarding quarantines and pay continuation and make adjustments as necessary.

ELIZABETH PUBLIC SCHOOLS DISTRICT RESPONSIBILITIES (CONTINUED)

- Communicate with and educate the school community and parents about approved public health practices and what each person can do to prepare or respond to minimize health risks.
- Develop and implement educational support plans for students who are isolated or quarantined.
- Develop a recovery plan that provides for education support and emotional support for staff and students. If there is loss of life, implement procedures located in the District's Crisis Management Plan.
- If needed, activate District Crisis Team and School Crisis Teams.
- Notify District Mental Health Crisis Team
- Document all actions taken.

ELIZABETH PUBLIC SCHOOLS SCHOOL RESPONSIBILITIES

- Identify chain of command in case of illness with a minimum of 2 back-ups for key administrators following School Facility Level Crisis Plan.
- Review best practices for respiratory hygiene and universal precautions and train all school staff, volunteers and students.
- Identify and procure needed resources.
- Review procedures for sending ill individuals home and make adjustments if necessary.
- Establish and implement surveillance reporting process to report the number of absent staff and students due to pandemic outbreak.

ELIZABETH PUBLIC SCHOOLS SCHOOL RESPONSIBILITIES (CONTINUED)

- Document all actions taken.
- Update staff and provide information on extent of infection at school site and potential changes that might take place at school.
- Follow District recovery plan that provides for education support and emotional support for staff and students.
- Maintain communications with District Office to update on the status of the situation at individual schools.
- Provide information to parents about the status of the situation using Blackboard Connect Messaging System and/or posting on District website.

COMMUNICATION GOALS

- Provide accurate, consistent, and comprehensive information about a pandemic outbreak including case definitions, treatment options, infection control measures, and reporting requirements.
- Instill and maintain public confidence in the schools and the County's public health care systems and their ability to respond to and manage a pandemic outbreak.
- Ensure an efficient mechanism for managing information between Union County Division of Health, emergency response agencies, health system partners and the schools.
- Contribute to maintaining order, minimizing public panic and fear, and facilitating public compliance by providing accurate, rapid, and complete information.
- Address rumors, inaccuracies, and misperceptions as quickly as possible, and prevent the stigmatization of affected groups.
- Ensure that all information released to the public is provided through Mayor Bollwage and Olga Hugelmeyer, Superintendent of Schools.

COMMUNICATIONS DURING PANDEMIC PHASES 1, 2, 3

- Union County Division of Health and/or City of Elizabeth Health Officer will:
 - Educate providers, public officials, schools and emergency responders about a pandemic and steps they should take to plan for pandemic outbreaks.
- Under the direction of the Superintendent/Designee, the District administration will:
 - Assess the needs of the schools.
 - Assess the information needs of the school community.
 - Intensify public education efforts about influenza pandemics and steps that can be taken to reduce exposure to infection. Information may be disseminated via web site postings, parent letters or school newsletters, Blackboard Connect Messaging System or Radio and TV announcements.
 - Coordinate with local County Division of Health and/or City of Elizabeth Health Officer and the NJ Department of Education to develop common health messages and education materials in multiple languages.

COMMUNICATIONS DURING PANDEMIC PHASES 4, 5, 6

Phase 4

• The School District should maintain communication with staff and parents to provide information on the current status of the situation and to alert them to a possible school closure. (Note: It is possible that the Health Officer may close schools during this phase. If so, notify Parents of this possibility.)

Phase 5

 Communication with staff and parents should be increased regarding the current status and to alert them to the likelihood of school closure in the near future.

Phase 6

Schools will be closed. Maintain communication with parents at home and with staff about the current status and plans for re-opening school.

MITIGATION

Mitigation activities are taken in advance of a pandemic outbreak to prevent or temper its impact. Mitigation efforts will occur primarily during the early pandemic phases (Phases 1-3).

- Elizabeth Public School District's pre-event mitigation activities include:
 - Planning, exercising, evaluating and revising the School Preparedness Plan.
 - Training and equipping staff to assure competencies and capacities needed to respond to a pandemic outbreak.
 - Developing strategic partnerships with local community health care institutions and providers, and local, state and federal response agencies and their staff.
 - Educating schools and parents about a pandemic outbreak and recommending preparedness measures.

MITIGATION (CONTINUED)

- Informing and updating schools about the potential impacts of a pandemic outbreak on essential services and city, county, and school infrastructure.
- Stockpiling necessary equipment and supplies that will be needed to respond to a pandemic outbreak including gloves, masks, hand sanitizers, and bleach.
- Establishing ventilation (HVAC) standards to be used during each phase of the pandemic outbreak (such as filter change schedules, etc.).
- Developing and implementing surveillance and reporting procedures to monitor illness patterns in the schools.

PUBLIC HEALTH STRATEGIES PANDEMIC PHASES 1, 2, 3

Individual Schools will:

- Increase hygiene education for staff, students and parents.
- Increase disease transmission control education for staff, students and parents.
- Increase symptom monitoring and attendance monitoring to ensure accurate reporting to the Union County Division of Health and/or City of Elizabeth Health Officer.

SOCIAL DISTANCING STRATEGIES PANDEMIC PHASES 4, 5, 6

The Union County Division of Health and/or City of Elizabeth Health Officer will recommend social distancing strategies to elected officials that are commensurate with the severity of illness and societal impact of the pandemic.

Specific, countywide strategies that may be recommended by the Health Officer include:

- Encouraging government agencies and the private sector to implement pandemic emergency staffing plans to maintain critical business functions while maximizing the use of telecommuting, flex schedules, and alternate work site options.
- Encouraging the public to use public transit only for essential travel; therefore transportation to schools may be interrupted.
- Advising County residents to defer non-essential travel to areas of the world affected by pandemic outbreaks.

SOCIAL DISTANCING STRATEGIES PANDEMIC PHASES 4, 5, 6 (CONTINUED)

Specific, countywide strategies that may be recommended by the Health Officer include:

- Suspending all public events where large numbers of people congregate including sporting events, concerts, and parades.
- Closure of all public and private daycare centers, schools and colleges.
- Suspension of all government functions not dedicated to addressing the impacts of the pandemic or maintaining critical continuity functions.
- Monitoring the effectiveness of social distancing strategies in controlling the spread of disease and advising appropriate decision-makers when social distancing strategies should be relaxed or ended.

MAINTENANCE OF ESSENTIAL SERVICES

- Phases 1, 2, 3
 - The School District will develop plans for maintaining essential departmental services during a pandemic.
- Phases 4, 5, 6
 - The School District will update its essential services plans and will assist the schools in updating their plans.
 - The Superintendent/Designee will determine the appropriate time to implement the continuity of operations plans and will notify district/school administrators.

RECOVERY

- School recovery from a pandemic will begin when school officials receive notice from the Union County Division of Health and/or City of Elizabeth Health Officer that schools may resume normal operations.
- The Superintendent/Designee will determine if normal supplies, resources and response systems are adequate to manage ongoing school activities.
- In consultation with the Union County Division of Health and/or City of Elizabeth Health Officer, the Superintendent/Designee will recommend specific actions to be taken to return the schools to pre-event status.

RECOVERY

■ The School District will

- Assess the economic and educational impact of the pandemic outbreak on the schools.
- Evaluate the response actions taken by the school district as a result of the pandemic.
- Determine effectiveness of existing plan to respond to similar events in the future.
- Revise existing plan as necessary to address any deficiencies.

COMMUNICATION GOALS

- Ensure that all information released to the public is provided through Mayor J. Christian Bollwage and Superintendent of Schools Olga Hugelmeyer.
 - Provide accurate, consistent, and comprehensive information about a pandemic outbreak including case definitions, treatment options, infection control measures, and reporting requirements.
 - Instill and maintain public confidence in the schools and the County's public health care systems and their ability to respond to and manage a pandemic outbreak.
 - Ensure an efficient mechanism for managing information between Union County Division of Health, emergency response agencies, health system partners and the schools.
 - Contribute to maintaining order, minimizing public panic and fear, and facilitating public compliance by providing accurate, rapid, and complete information.
 - Address rumors, inaccuracies, and misperceptions as quickly as possible, and prevent the stigmatization of affected groups.

INSTRUCTIONAL PLAN

NJDOE required elements of the Schools Preparedness Plan:

- Equitable access to instruction for all students
- Provision of appropriate special education/related services for students with disabilities
- Provision of school nutrition benefits or services for eligible students

HOME INSTRUCTION 6A:16-10.1

- In the event a board of education is provided a written directive by either the New Jersey Department of Health or the health officer of the City of Elizabeth to close due to a public health-related event, the board of education may utilize home instruction to provide instructional services to enrolled students.
- The provision of home instruction services shall be guided by N.J.A.C. 6A:16-10.1 and will include direct services, online instruction, or any other means developed by the district to meet the needs of its students.
- Any day in which students impacted by a public health-related closure and have access to home instruction services will count as a day in which the board of education has provided public school facilities toward its compliance with the 180day requirement in accordance with N.J.S.A. 18A:7F-9.








E-Remote-learning allows the Elizabeth Public School District to extend learning into the home and keep everyone safe during emergency closures.

E-Remote-learning is learning utilizing electronic technologies to access specific educational curriculum outside of a traditional classroom. While in most cases it refers to a course, program or degree delivered completely online, for the purpose of this unique situation it pertains to leveraging electronic technology to insure there is not an interruption in the delivery of instruction.

Lessons will be provided to each student consisting of assignments that will cover 14 to 30 days.

WHAT CAN I DO TO MAKE SURE MY STUDENT IS SUCCESSFUL WITH THEIR REMOTE LEARNING DAY?

Our number one goal with E-Remote Learning is to make sure your child continues to learn and is safe.

With a new process, there will be many things your student can share about their learning and demonstrate success, but there will also be some areas of improvement for the whole system.

When students return to school, there will be an opportunity for the home and students to share, strengths and needs improvement, about the E-Remote Learning Day.

HOW WILL MY CHILD GET THE REMOTE LEARNING ASSIGNMENTS THAT THEY NEED TO COMPLETE AT HOME?

- Teachers will have lessons for their student via packets and/or uploaded in PowerSchool Unified Classroom, our learning management system for students.
- Prior to leaving the school building, students will receive the necessary resources to complete their work at home.
- Students who are English Language Learners/special education will receive additional materials
- Students, grades 3-12, will be able to use Office 365 (create and edit documents, Microsoft Excel (create and edit spreadsheets), Microsoft PowerPoint (create and edit presentations), and Microsoft Publisher (create and edit diagrams) offline.
- There will be some lessons that will have videos or other media. Teachers will work with the students to have this information downloaded to their laptop, prior to leaving the school for the day.
