***The 2024-2025 school year will begin on Friday, September 6<sup>th</sup>, 2024.*** Instruction will be conducted during the hours of 8:20 a.m. to 3:00 p.m. In order to help facilitate both a smooth and orderly mode of transition during the times of arrival and dismissal, please adhere to the following safety procedures:

**Students in Grades K-6  
will be attending the Christopher Columbus School No. 15 MAIN Building  
located at 511 Third Avenue**

TCUs (enter through S. Fifth Street): Kindergarten students in TCU 1, TCU 2, and TCU 3 report directly to their classroom doors.

Door 1 - (S. Fifth Street next to TCUs): 1-009, 1-012, 1-010, 2-014, 3-111, 3-112, 3-113, and 6-213

Door 2 - (S. Fifth Street closest to Third Avenue): 4-205, 4-206, 4-208, 4-209, 6-210, and 6-212

Door 4 - (Spencer Street closest to Third Avenue): 2-105, 1-106, 2-108, 1-109, 3-110, and 5-204

Door 5 - (Spencer Street next to parking lot): K-003, K-004, 2-102, 5-201, 2-101, 5-202, and 5-203

**Students in Grades 7 and 8 who would like to eat breakfast in school should report to school at 7:45 a.m. and enter through Door 1. Breakfast will be available from 7:45 a.m. to 8:15 a.m. and will not be provided in the classrooms.**

**\*Students will not be permitted on the playground/parking lot prior to or after school hours.**

### **IMMUNIZATION REQUIREMENTS**

The state of New Jersey has mandated that all children born after January 1<sup>st</sup>, 1997 and enrolled in Grade Six, **will be required to receive a booster dose of the diphtheria, tetanus and pertussis vaccine (Tdap) as well as one dose of meningococcal vaccine.** Documentation that your child has received the required sixth grade immunizations must be turned into the school nurse no later than ***Friday, September 6<sup>th</sup>, 2024.***

Students entering 6<sup>th</sup> grade with birthdays on or after ***Friday, September 6<sup>th</sup>, 2024*** must provide written confirmation from your child’s healthcare provider of the vaccination appointment. This appointment should be within two weeks of your child turning 11 years of age. The immunization

record must be submitted immediately following the appointment. The Elizabeth Public School District is compelled by law to ensure that all students receive their required immunizations.

**Children who do not meet immunization requirements or do not have documentation of a scheduled appointment within two weeks of turning 11 years of age will be excluded from school beginning the first school day.**

#### **TRANSPORTATION**

Transportation will be available for the following students:

- Elementary students who live more than 2.0 miles from their school
- High school students who live more than 2.5 miles from their school
- Students whose IEP include transportation services
