**FIRST DAY OF SCHOOL / ARRIVAL AND DISMISSAL PROCEDURES**

**The 2024-2025 school year will begin on Friday, September 6, 2024.** Instruction will be conducted during the hours of 8:20 a.m. to 3:00 p.m. In order to help facilitate both a smooth and orderly mode of transition during the times of arrival and dismissal, please adhere to the following safety procedures:

- Please see address label on the outside of the envelope for the student's homeroom number.
- Students in **Grades 6-8**, who eat breakfast, will be able to enter the building through the front doors from 8:00 a.m. to 8:15 a.m.
- Students in grades K-6 will eat breakfast in their classrooms beginning at 8:25 a.m.

- All doors will open at 8:20 a.m. for students. Please do not leave your child unattended on school property before the start of the school day. Students in grades K-5 will report directly to their homerooms. Students in grades 6-8 will report to the cafeteria for pick-up.
- Students arriving **after 8:25 a.m.** will enter through the front main entrance of the school. These students will be considered late and the tardy will be marked as such in their attendance. Disciplinary actions may be taken.
- Dismissal is at 3:00 p.m. at the designated exit doors; please make every effort to pick up your child on time.

#### **Entering & Exiting the Main Building**

- Kindergarten students will enter and exit through the Kindergarten area. Dismissal is at 2:55 p.m.
- Students in Grades 1-2 will use Stairwell No. 2 to enter and exit onto South Seventh Street (student pick-up and drop off will be in the courtyard). Dismissal is at 3:00 p.m.
- Students in Grade 3 LLD, Grade 4 LLD, and Grade 5 LLD will enter through the main entrance.
- ***Students in Grades 3-4 will use Stairwell No. 3. Students will line up on the sidewalk in the morning and will exit through the doors onto High Street. Dismissal is at 2:55 p.m. (New Procedure)***
- Students in Grades 6-8 will enter each morning through the main entrance.
- Students in Grades 6-7 will use the Stairwells on High Street and at the main entrance for dismissal.
- ***Students in Grade 8 will enter through the main entrance and exit Stairwell No. 1 on to South Seventh Street. (New Procedure)***

#### **Entering & Exiting the Annex - Grades 4 & 5**

- All students will enter at 8:20 a.m. and exit at 3:00 p.m. through the school yard doors located in the back of the Annex building on Anna Street. Any student entering the building after 8:25 a.m. must use the Bond Street entrance and will receive a late pass. Our main entrance of the school is located at 943 Bond Street. All parents and visitors must use this entrance when visiting our building.
- Students in Grades 4 & 5 at the Annex will be able to enter at 8:00 a.m. to eat breakfast.

#### **POWERSCHOOL PARENT PORTAL INSTRUCTIONS**

PowerSchool is an electronic management system that is utilized by the Elizabeth Public Schools in order to collect, store, and maintain pertinent student data and records. The application provides parents with real-time access to information that pertains to a student's schedule, attendance, grades, and academic progress; it also offers a convenient and accommodating way for both parents and teachers to communicate as needed. Therefore, everyone stays connected. Schedules for the upcoming 2024-2025 school year will be available to view on PowerSchool on **Thursday, August 29<sup>th</sup>**.

#### **NEW AND RETURNING PARENTS TO EPS**

### **IMMUNIZATION REQUIREMENTS**

The state of New Jersey has mandated that all children born after January 1<sup>st</sup>, 1997 and enrolled in Grade Six, **will be required to receive a booster dose of the diphtheria, tetanus and pertussis vaccine (Tdap) as well as one dose of meningococcal vaccine.** Documentation that your child has received the required sixth grade immunizations must be turned into the school nurse no later than ***Friday, September 6<sup>th</sup>, 2024.***

Students entering 6<sup>th</sup> grade with birthdays on or after ***Friday, September 6<sup>th</sup>, 2024,*** must provide written confirmation from your child’s healthcare provider of the vaccination appointment. This appointment should be within two weeks of your child turning 11 years of age. The immunization record must be submitted immediately following the appointment. The Elizabeth Public School District is compelled by law to ensure that all students receive their required immunizations.

**Children who do not meet immunization requirements or do not have documentation of a scheduled appointment within two weeks of turning 11 years of age will be excluded from school beginning the first school day.**
