Students in Grades Kindergarten-5 will eat breakfast in their classrooms upon arrival at 8:20 a.m.

Here at Abraham Lincoln School No. 14, we take the attendance of students very seriously and adhere to the Elizabeth Public Schools Attendance Policy, whereas students are not permitted to be absent for more than **nine (9) days**. High absenteeism and tardiness are linked to lower student achievement as well as a decrease in student learning. Please be reminded that, in addition to absenteeism, student tardiness is also a part of attendance. It is extremely important that students report to school on time and are ready to learn every day.

Please be reminded that ALL visitors must enter the building through the front door and check in with security. **NO visitor will be allowed to enter the building without proper photo identification.** Parents and visitors may NOT enter the building through any other door before, during, and/or after the school day. Also, to ensure smooth daily operations, appointments are required. Please contact the school to schedule an appointment/meeting/conference.

The use of the following items in school is strictly prohibited: cell phones, iPods, Game Boys, other handheld electronic games, card collections of any kind, etc. All cell phones and electronic devices MUST be turned in each morning. If an item is found, heard, and/or seen, it will be confiscated. On the first offense, the device will be returned to the student at the end of the day. On the second offense, the electronic device will only be returned to a parent. On the third and final offense, the electronic device will be returned on the last day of school. In addition, the **school is not responsible** if any of these items are lost, stolen or damaged on school grounds.

PowerSchool is an electronic management system that is utilized by the Elizabeth Public Schools in order to collect, store, and maintain pertinent student data and records. The application provides parents with real-time access to information that pertains to a student's schedule, attendance, grades, and academic progress; it also offers a convenient and accommodating way for both parents and teachers to communicate as needed. Therefore, everyone stays connected. Schedules for the upcoming 2024-2025 school year will be available to view on PowerSchool on **Thursday, August 29th**.

NEW AND RETURNING PARENTS TO EPS

Parents of new students must request a new account in order to input all of the information required to navigate the PowerSchool Parent Portal. Parents of existing students will need to log in, input, and update any changed information that has occurred for their child.

IMMUNIZATION REQUIREMENTS

The state of New Jersey has mandated that all children born after January 1st, 1997 and enrolled in Grade Six, **will be required to receive a booster dose of the diphtheria, tetanus and pertussis vaccine (Tdap) as well as one dose of meningococcal vaccine.** Documentation that your child has received the required sixth grade immunizations must be turned into the school nurse no later than ***Friday, September 6th, 2024.***

Students entering 6th grade with birthdays on or after ***Friday, September 6th, 2024*** must provide written confirmation from your child’s healthcare provider of the vaccination appointment. This appointment should be within two weeks of your child turning 11 years of age. The immunization record must be submitted immediately following the appointment. The Elizabeth Public School District is compelled by law to ensure that all students receive their required immunizations.
