### **FIRST DAY OF SCHOOL / ARRIVAL AND DISMISSAL PROCEDURES**

**The 2024-2025 school year will begin on Friday, September 6<sup>th</sup>, 2024.** Instruction will be conducted during the hours of 8:20 a.m. to 3:00 p.m. In order to help facilitate both a smooth and orderly mode of transition during the times of arrival and dismissal, please adhere to the following safety procedures:

#### **MORNING ARRIVAL PROCEDURES (8:20 A.M.):**

**K-134, K-137** will enter through their respective classrooms on Durant Street.

**K-103** will enter through room 137 on Durant Street.

**K-102** will enter through the classroom on the opposite side of Durant Street (1<sup>st</sup> door).

**Grades 1, 2, and 3** – will line up in front of the school on Cross Avenue according to their homerooms. Their teachers will meet them in front and walk them into the building.

**Grades 4, 5, 6, 7, and 8 - Arriving between 7:50 a.m. - 8:20 a.m.** - Students must enter through the side entrance (brown doors at the end of Durant Street) and report directly to the

cafeteria. Breakfast will be served from 7:50 a.m. - 8:20 a.m. Students reporting late (after 8:20 a.m.) must enter through the main entrance and sign in as tardy.

**AFTERNOON DISMISSAL PROCEDURES (3:00 P.M.):**

**K-134, K-137**- their respective classrooms on Durant Street.

**K-103**- room 137 on Durant Street.

**K-102**- their classroom on the opposite side of Durant Street.

**Grades 1 and 2- Playground**- parents enter through the left side of the building (opposite side of Durant Street) and walk to the back of the building.

**Grades 3 and 5** - On Durant Street- **1<sup>st</sup> doors** near Cross Avenue.

**Grade 4** - Left side of the building (opposite side of Durant Street)- **2<sup>nd</sup> doors**.

**Grades 6, 7, and 8** - Durant Street. **Last doors** near the end of the street.

## NEW AND RETURNING PARENTS TO EPS

### **IMMUNIZATION REQUIREMENTS**

The state of New Jersey has mandated that all children born after January 1<sup>st</sup>, 1997 and enrolled in Grade Six, **will be required to receive a booster dose of the diphtheria, tetanus and pertussis vaccine (Tdap) as well as one dose of meningococcal vaccine.** Documentation that your child has received the required sixth grade immunizations must be turned into the school nurse no later than ***Friday, September 6<sup>th</sup>, 2024.***

Students entering 6<sup>th</sup> grade with birthdays on or after ***Friday, September 6<sup>th</sup>, 2024*** must provide written confirmation from your child’s healthcare provider of the vaccination appointment. This appointment should be within two weeks of your child turning 11 years of age. The immunization record must be submitted immediately following the appointment. The Elizabeth

Public School District is compelled by law to ensure that all students receive their required immunizations.

**Children who do not meet immunization requirements or do not have documentation of a scheduled appointment within two weeks of turning 11 years of age will be excluded from school beginning the first school day.**

**TRANSPORTATION**

Transportation will be available for the following students:

- Elementary students who live more than 2.0 miles from their school
- High school students who live more than 2.5 miles from their school
- Students whose IEP include transportation services
