Dear Parents/Guardians and Students,

We, the entire staff here at *Dr. Albert Einstein Academy School No. 29*, are honored and elated to welcome all of our students and family members to the 2024-2025 school year *beginning on Friday, September 6th*! Our promise is to provide an innovative and personalized learning environment that ensures that every child achieves excellence. Within a safe, rigorous, and welcoming environment, we believe that every student can and will learn at his/her optimal level in order to reach their highest educational potential.

FIRST DAY OF SCHOOL / ARRIVAL AND DISMISSAL PROCEDURES

The 2024-2025 school year will begin on Friday, September 6th, 2024. Instruction will be conducted during the hours of 8:20 a.m. to 3:00 p.m. In order to help facilitate both a smooth and orderly mode of transition during the times of arrival and dismissal, please adhere to the following safety procedures:

- **Pre-K:** Students will line up in the Pre-K playground. Doors will open at 8:20 a.m. and close promptly at **8:30 a.m**. If a student arrives after 8:30 a.m., he/she must be brought through the main entrance to be signed in. A symbol has been included for your child to wear on the first day with teacher and homeroom information.
- Afterschool dismissal for all Pre-K students will take place in the cafeteria. Please enter through the side cafeteria door.



- Doors for **Grades K-8** will open at 7:50 a.m. <u>Students in Grades K-4</u> will enter through the side gym door, located on the path to the playground. <u>Students in Grades 5-8</u> will enter through the front main entrance and proceed to the cafeteria. Parents <u>will not</u> be allowed beyond entrance points.
- **Dismissal for Kindergarten-3rd Grade students** will take place in the cafeteria. Dismissal for **Grades 4-8 students** will take place on Main Playground. In the event of inclement weather, dismissal will be moved to the cafeteria for all students.
- A dismissal card is included for each student. Please be sure it is filled out and sent with student on the first day to ensure a smooth and safe dismissal of all students.
- <u>All 2024-2025 homeroom assignments can be found by logging into the Powerschool</u> <u>Parent Portal and can also be found on the front label of the mailing envelope.</u>
- Also enclosed, for your immediate review, is the District's Afterschool Dismissal Policy. If your child plans to take the bus home, you <u>do not</u> need to fill out the enclosed form; however, if your child walks home, it is <u>mandatory</u> that you fill out the form. Please return the form on the first day of school on *Friday*, *September 6th*.
- Gentle Reminder: Our school is located on a main road. Therefore, when dropping off or picking-up your child, please do not double park in front of the building. Please be mindful of our neighbors and do not block private driveways. In addition, please do not block the school driveway; the driveway in front of the building is designated for buses ONLY. Student safety is among our top priorities, and we hope to make the morning and afternoon transitions as orderly as possible.

There will be staff members outside to assist everyone during the first week of school.

POWERSCHOOL PARENT PORTAL INSTRUCTIONS

PowerSchool is an electronic management system that is utilized by the Elizabeth Public Schools in order to collect, store, and maintain pertinent student data and records. The application provides parents with real-time access to information that pertains to a student's schedule, attendance, grades, and academic progress; it also offers a convenient and accommodating way for both parents and teachers to communicate as needed. Therefore, everyone stays connected. Schedules for the upcoming 2024-2025 school year will be available to view on PowerSchool on *Thursday, August 29th*.

NEW AND RETURNING PARENTS TO EPS

Parents of new students must request a new account in order to input all of the information required to navigate the PowerSchool Parent Portal. Parents of existing students will need to log in, input, and update any changed information that has occurred for their child.

You will then be directed to complete an online contact form. After clicking the *Save* and *Done* buttons at the bottom, your request will be submitted and someone from the school will be in contact with you as soon as possible.

UNIFORM POLICY

The intended purpose for the EPS dress code is to promote a positive self-image and to enhance school pride amongst our students. Health, safety, and educational well-being are the primary objectives for the dress code with the goal of fostering an environment that is conducive to discipline as well as to education. School uniforms are expected to be worn on a daily basis.

ELECTRONIC DEVICES

Pre-K:

The implementation of iPads into the preschool classrooms provides an opportunity for our youngest students to extend their learning through developmentally appropriate active-learning experiences. While the iPad can serve as a tool to help reinforce skills in the areas of reading, writing and mathematics, it can also provide opportunities for preschool students to investigate, explore, and create within the early childhood setting.

The implementation of the iPad is integrated seamlessly into the preschool curriculum during center time. iPads enhance student learning by providing opportunities for students to retell and **Dr. Albert Einstein Academy School No. 29**



create their own stories, investigate and explore exciting new places and diverse cultures, capture their learning through student created portfolios, and reinforce skills through books and learning applications.

<mark>K-8:</mark>

For the past few years, our school has operated as a 1:1 technology school; and as a result, all students will continue to utilize a *laptop computer* for their daily classroom instruction. Students should make every effort to take excellent care of their *laptops* throughout the school year, as this is a very special privilege. Our 1:1 technology implementation will continue to ensure that our students attain the competitive standards that are needed to foster both college and career readiness. *All students are required to bring their charged laptops and power cords to school daily*.

NEW ENTRANTS

All new students to the district will receive their laptop during the first week of school.

NEW AND EXISTING PARENT INSTRUCTIONS

It is extremely important that we have the most updated home address and/or phone numbers so that we may contact you in the event of an emergency or to discuss your child's progress. Please be sure to update your contact information by logging into your PowerSchool Parent Portal and filling out the Emergency Information form found under the Forms link throughout the course of the school year should there be a change in either your home address and/or phone number. Open communication between the home and the school is expected and is one of the more pertinent keys to academic success in school.

Our Notification System enables staff members to contact parents through email, text, and through verbal messages recorded on the phone. Through this system, parents are immediately alerted of urgent information, major events, and/or upcoming dates. To ensure that this system



will continue to operate in a highly effective manner, it is very important that we have <u>the most</u> <u>current and accurate information on file for each and every student.</u>

IMMUNIZATION REQUIREMENTS

Pre-K:

Please be advised that the State of New Jersey, Department of Health Services, has changed several immunization requirements. All children attending licensed childcare centers and preschools are required to receive an annual flu vaccination.

Please provide proof of your child's required immunization as soon as possible and *no later than* **December 20th**, **2024**. Students who do not have the required documentation will be excluded from school as of **January 2nd**, **2025**.

<mark>K-8:</mark>

The state of New Jersey has mandated that all children born after January 1st, 1997 and enrolled in Grade Six, **will be required to receive a booster dose of the diphtheria, tetanus and pertussis vaccine (Tdap) as well as one dose of meningococcal vaccine.** Documentation that your child has received the required sixth grade immunizations must be turned into the school nurse no later than *Friday, September 6th*, 2024.

Students entering 6th grade with birthdays on or after *Friday, September 6th, 2024* must provide written confirmation from your child's healthcare provider of the vaccination appointment. This appointment should be within two weeks of your child turning 11 years of age. The immunization record must be submitted immediately following the appointment. The Elizabeth Public School District is compelled by law to ensure that all students receive their required immunizations.

<u>Children who do not meet immunization requirements or do not have documentation of a scheduled appointment within two weeks of turning 11 years of age will be excluded from school beginning the first school day.</u>

TRANSPORTATION

Transportation will be available for the following students:

• Elementary students who live more than 2.0 miles from their school Dr. Albert Einstein Academy School No. 29



- High school students who live more than 2.5 miles from their school
- Students whose IEP include transportation services

SCHOOL SUPPLIES

Pre-K:

On the first day of school, please send your child in with the following items:

- One (1) small crib size sheet and blanket for rest time (labeled with his/her name).
- A complete change of clothes for your child labeled with his/her name (underwear, socks, shirt, pants/skirt). This extra change of clothing does not have to be the school uniform.
- A full-sized book bag (no rolling book bags please).
