FIRST DAY OF SCHOOL / ARRIVAL AND DISMISSAL PROCEDURES

The 2025-2026 school year will begin on Thursday, September 4th, 2025. Instruction will be conducted during the hours of 8:20 a.m. to 3:00 p.m. In order to help facilitate both a smooth and orderly mode of transition during the times of arrival and dismissal, please adhere to the following safety procedures:

The procedure for morning arrival will be drop-and-go to maintain a continuous flow of traffic in the neighborhood. ***The drop-and-go area on Shelley Avenue will be marked off with cones. We kindly ask that you pull up to the last cone when dropping off your child. There is no parking in the drop-and-go area.***

Parents who wish to stay and watch their child enter the building should park their car on one of the surrounding streets and walk their child to their designated entrance. Shelley Avenue will be closed to motor vehicle traffic at dismissal.

Students arriving to school ***after 8:25 a.m. are considered late*** and must enter the building through the main entrance and obtain a late pass from security. ***Students who are consistently late to school are subject to disciplinary action as per the district's code of student conduct.***

Dismissal is at 3:00 p.m. Students lose valuable instructional time when they are signed out of school before 3:00 p.m. To prevent the loss of instructional time and maintain an orderly dismissal, students cannot be signed out between 2:30 p.m. - 3:00 p.m.

POWERSCHOOL PARENT PORTAL INSTRUCTIONS

PowerSchool is an electronic management system that is utilized by the Elizabeth Public Schools in order to collect, store, and maintain pertinent student data and records. The application provides parents with real-time access to information that pertains to a student's schedule, attendance, grades, and academic progress; it also offers a convenient and accommodating way for both parents and teachers to communicate as needed. Therefore, everyone stays connected. Schedules for the upcoming 2025-2026 school year will be available to view on PowerSchool on ***Monday, August 18th***.

NEW AND RETURNING PARENTS TO EPS

Parents of new students must request a new account in order to input all of the information required to navigate the PowerSchool Parent Portal. Parents of existing students will need to log in, input, and update any changed information that has occurred for their child.

UNIFORM POLICY

The intended purpose for the EPS dress code is to promote a positive self-image and to enhance school pride amongst our students. ELECTRONIC DEVICES

Pre-K:

The implementation of iPads into the preschool classrooms provides an opportunity for our youngest students to extend their learning through developmentally appropriate active-learning experiences. While the iPad can serve as a tool to help reinforce skills in the areas of reading, writing and mathematics, it can also provide opportunities for preschool students to investigate, explore, and create within the early childhood setting.

The implementation of the iPad is integrated seamlessly into the preschool curriculum during center time. iPads enhance student learning by providing opportunities for students to retell and create their own stories, investigate and explore exciting new places and diverse cultures, capture their learning through student created portfolios, and reinforce skills through books and learning applications.

K-8:

For the past few years, our school has operated as a 1:1 technology school; and as a result, all students will continue to utilize a laptop computer for their daily classroom instruction. Students should make every effort to take excellent care of their laptops throughout the school year, as this is a very special privilege. Our 1:1 technology implementation will continue to

IMMUNIZATION REQUIREMENTS

Pre-K:

Please be advised that the State of New Jersey, Department of Health Services, has changed several immunization requirements. All children attending licensed childcare centers and preschools are required to receive an annual flu vaccination.

Please provide proof of your child’s required immunization as soon as possible and ***no later than December 23rd, 2025***. Students who do not have the required documentation will be excluded from school as of ***January 5th, 2026***.

K-8:

The state of New Jersey has mandated that all children born after January 1st, 1997 and enrolled in Grade Six, **will be required to receive a booster dose of the diphtheria, tetanus and pertussis vaccine (Tdap) as well as one dose of meningococcal vaccine.** Documentation that your child has received the required sixth grade immunizations must be turned into the school nurse no later than ***Thursday, September 4th, 2025***.

Students entering 6th grade with birthdays on or after ***Thursday, September 4th, 2025*** must provide written confirmation from your child’s healthcare provider of the vaccination

appointment. This appointment should be within two weeks of your child turning 11 years of age. The immunization record must be submitted immediately following the appointment. The Elizabeth Public School District is compelled by law to ensure that all students receive their required immunizations.

Children who do not meet immunization requirements or do not have documentation of a scheduled appointment within two weeks of turning 11 years of age will be excluded from school beginning the first school day.

TRANSPORTATION

Transportation will be available for the following students:

- Elementary students who live more than 2.0 miles from their school
- High school students who live more than 2.5 miles from their school
- Students whose IEP include transportation services
