FIRST DAY OF SCHOOL / ARRIVAL AND DISMISSAL PROCEDURES

The 2025-2026 school year will begin on Thursday, September 4th, 2025. Instruction will be conducted during the hours of 8:20 a.m. to 3:00 p.m. In order to help facilitate both a smooth and orderly mode of transition during the times of arrival and dismissal, please adhere to the following safety procedures:

The classroom assignment for your child can be found on the envelope for this document. The school will begin arrival procedures at 7:50 a.m. We ask that all students report to school on time by 8:20 a.m. and that they enter through their assigned door as indicated below:

Grade Level	Arrival Locations
Grades K* - 4	Main Entrance on First Avenue Students will remain in the gymnasium until homeroom begins and have breakfast in their classrooms after they are picked up by the teacher.
Grades 5 - 8	Cafeteria Doors (Playground Area) Students will remain in the cafeteria until the homeroom begins. Breakfast will be served in the cafeteria between 7:50 AM and 8:10 AM.
*Only Kindergarten parents (Homerooms K-012, K-013, K-102, & K-103) have the option of dropping off their child at the classroom door at 8:20 a.m. Any time before 8:20 a.m. students must be dropped off at the Main Entrance.

Any student arriving after 8:20 a.m. will be marked tardy and must enter through the main doors on First Avenue.

Dismissal Procedures Parents/guardians are required to pick up students at their designated exits. No student shall be dismissed earlier than 3:00 p.m. Siblings will be required to pick up younger brothers/sisters at their designated exit.

Homerooms 1-010 and 1-011	Side Door on First Avenue (Exit 2)
Homerooms 2-004, 2-005, 2-006, and 2-007	Main Office Doors (Playground Area) – (Exit 3)
Homerooms 1-008, 3-001, 3-003, and 3-009	Main Entrance on First Avenue (Exit 1)
Grades 4 - 5	Cafeteria Doors (Playground Area) (Exit 5)
Grades 6 - 8	Dismissed onto Elizabeth Avenue

There will be staff members outside to assist everyone during the first week of school.

Labels: To help us identify all our students on the first day of school, we have placed a label in this envelope. We ask that you write your child's first and last name on the label. All students should wear the label on the first day of school. Also, please remember to label all your child's belongings including their uniform sweaters.

Note: We are a peanut-free school so food items containing peanuts will not be allowed in school. In addition, soda, energy drinks, and any glass beverages are not permitted.

Cell Phones: Cell phones must remain off and in a student's backpack or it will be taken and sent to the office and a parent/guardian will be notified. Additionally, students will not be allowed to wear any Bluetooth listening devices during the school day. Bluetooth devices must remain in their backpacks or will be taken and sent to the office for a parent to pick up.

PowerSchool is an electronic management system that is utilized by the Elizabeth Public Schools in order to collect, store, and maintain pertinent student data and records. The application provides parents with real-time access to information that pertains to a student's schedule, attendance, grades, and academic progress; it also offers a convenient and accommodating way for both parents and teachers to communicate as needed. Therefore, everyone stays connected. Schedules for the upcoming 2025-2026 school year will be available to view on PowerSchool on ***Monday, August 18th***.

NEW AND RETURNING PARENTS TO EPS

Parents of new students must request a new account in order to input all of the information required to navigate the PowerSchool Parent Portal. Parents of existing students will need to log in, input, and update any changed information that has occurred for their child.

IMMUNIZATION REQUIREMENTS

The state of New Jersey has mandated that all children born after January 1st, 1997 and enrolled in Grade Six, **will be required to receive a booster dose of the diphtheria, tetanus and pertussis vaccine (Tdap) as well as one dose of meningococcal vaccine.** Documentation that your child has received the required sixth grade immunizations must be turned into the school nurse no later than *Thursday, September 4th, 2025*.

Students entering 6th grade with birthdays on or after *Thursday, September 4th, 2025* must provide written confirmation from your child’s healthcare provider of the vaccination appointment. This appointment should be within two weeks of your child turning 11 years of age. The immunization record must be submitted immediately following the appointment. The Elizabeth Public School District is compelled by law to ensure that all students receive their required immunizations.

Children who do not meet immunization requirements or do not have documentation of a scheduled appointment within two weeks of turning 11 years of age will be excluded from school beginning the first school day.

TRANSPORTATION

Transportation will be available for the following students:

- Elementary students who live more than 2.0 miles from their school
- High school students who live more than 2.5 miles from their school
- Students whose IEP include transportation services
