Dear Parents/Guardians and Students,

We, the entire staff here at **Terence C. #### **FIRST DAY OF SCHOOL / ARRIVAL AND DISMISSAL PROCEDURES**

***The 2025-2026 school year will begin on Thursday, September 4<sup>th</sup>, 2025.*** Instruction will be conducted during the hours of 8:20 a.m. to 3:00 p.m. In order to help facilitate both a smooth and orderly mode of transition during the times of arrival and dismissal, please adhere to the following safety procedures:

**Arrival Procedures:** (Entrance/Exit Doors have Signs indicating Grade Level Entrance/Exit)

- **Students in PreK & HR G6-K/1 (new classroom):** Will enter using the Cafeteria Entrance and Ground Floor Entrance on Loomis Street. Doors will open at 8:20 a.m. and breakfast will be served in the homeroom.
- **Students in Grades 2<sup>nd</sup> & 3<sup>rd</sup>:** Will enter using the entrance on First Avenue. Doors will open at 8:00 a.m. and breakfast will be served in the homeroom.
- **Students in Grades 4<sup>th</sup> & 5<sup>th</sup>:** Will enter using the Main Entrance on Loomis Street. Doors will open at 8:00 a.m. and breakfast will be served in the homeroom.

- **Students in Grades 6<sup>th</sup> to 8<sup>th</sup>:** Will enter using the entrance on Second Avenue at 7:50 a.m. for breakfast in the cafeteria.
- **Students arriving on the bus:** Will enter using the Rankin Street entrance.

**Dismissal Procedures:** (Please Bring ID with you when picking up your child)

**Pre-K Students & HR G6 K/1:** *Doors will open for Pre-K dismissal at 2:45 p.m.* Students will be dismissed from the **Cafeteria Exit and Ground Floor Exit on Loomis Street**. (Same entrance they enter in the morning.)

**Parent Pick-Up: (Various Locations)**

- **2<sup>nd</sup> and 3<sup>rd</sup> Grade:** Students will be dismissed from the **Playground on 1<sup>st</sup> Avenue and Rankin Street at 3:00 p.m.** (Same side of the building that the students enter in the morning.) **During inclement weather:** 2<sup>nd</sup> and 3<sup>rd</sup> Grade students will be dismissed from the Auditorium Doors on 1<sup>st</sup> Avenue. (Same entrance that they enter in the morning.)
- **4<sup>th</sup> and 5<sup>th</sup> Grade:** Students will be dismissed in front of the **Main Entrance on Loomis Street**. (Same entrance that they enter in the morning.) **During inclement weather:** 4<sup>th</sup> and 5<sup>th</sup> grade students will be dismissed from the Main Entrance Door on Loomis Street.
- **6<sup>th</sup>, 7<sup>th</sup>, and 8<sup>th</sup> Grade:** Students will be dismissed from the **Auditorium Doors on Loomis Street**.
- **Homerooms 105, 206, & 207:** Students will be dismissed from the **Gym 1 Door** which exits onto the **Playground on Rankin Street**. Please Bring ID with you when picking up your child.

**Walkers:** Students will continue to be dismissed from the **2<sup>nd</sup> Avenue Exit**. Students must exit the building and school grounds at this time. Parent/Guardian must fill out the dismissal procedure paperwork to grant permission before student is approved to be a walker.

**Busing Students:** Students will board their designated routes and be transported to the locations indicated on their transportation letters. Letters containing bus route information will be sent home by the Elizabeth Public Schools Transportation Department during the **last week of August**. Students who qualify must live more than 2.0 miles from the school.

**Important Message about Parking for Student Pick-up:** Regarding **daily parking**, please note that Loomis Street is a one-way street. Please refrain from double-parking to allow for a smooth transition of arrival/dismissal procedures and entry into the building.

Please ensure that **BLUE** dismissal procedure paperwork included in this mailer is returned on **Thursday, September 4<sup>th</sup>**. Visit the EPS website at <https://www.epsnj.org/Page/4374> and follow the instructions provided on how to update your information in PowerSchool.

There will be staff members outside to assist everyone during the first week of school. **Please ensure that your child is aware of their designated dismissal plan, as this is essential for a safe and orderly end to the school day. You must call the main office or contact the homeroom teacher via email before 2:00pm if dismissal plans are changed. Also, no early dismissal will be permitted after 2:30pm.**

#### **POWERSCHOOL PARENT PORTAL INSTRUCTIONS**

PowerSchool is an electronic management system that is utilized by the Elizabeth Public Schools in order to collect, store, and maintain pertinent student data and records. The application provides parents with real-time access to information that pertains to a student's schedule, attendance, grades, and academic progress; it also offers a convenient and accommodating way for both parents and teachers to communicate as needed. Therefore, everyone stays connected. Schedules for the upcoming 2025-2026 school year will be available to view on PowerSchool on **Monday, August 18<sup>th</sup>**.

**\* As we continue to finalize enrollment and system updates, please be aware that student schedules and homeroom assignments may change up until the first day of school. ### **ELECTRONIC DEVICES**

#### **Pre-K:**

The implementation of iPads into the preschool classrooms provides an opportunity for our youngest students to extend their learning through developmentally appropriate active-learning experiences. While the iPad can serve as a tool to help reinforce skills in the areas of reading, writing and mathematics, it can also provide opportunities for preschool students to investigate, explore, and create within the early childhood setting.

The implementation of the iPad is integrated seamlessly into the preschool curriculum during center time. iPads enhance student learning by providing opportunities for students to retell and create their own stories, investigate and explore exciting new places and diverse cultures, capture their learning through student created portfolios, and reinforce skills through books and learning applications.

#### **K-8:**

**For the past few years, our school has operated as a 1:1 technology school; and as a result, all students will continue to utilize a *laptop computer* for their daily classroom instruction.** Students should make every effort to take excellent care of their *laptops* throughout the school year, as this is a very special privilege. Our 1:1 technology implementation will continue to ensure that our students attain the competitive standards that are needed to foster both college and career readiness. *All students are required to bring their charged laptops and power cords to school daily.*

### **IMMUNIZATION REQUIREMENTS**

#### **Pre-K:**

Please be advised that the State of New Jersey, Department of Health Services, has changed several immunization requirements. All children attending licensed childcare centers and preschools are required to receive an annual flu vaccination.

Please provide proof of your child’s required immunization as soon as possible and ***no later than December 23<sup>rd</sup>, 2025***. Students who do not have the required documentation will be excluded from school as of ***January 5<sup>th</sup>, 2026***.

#### **K-8:**

The state of New Jersey has mandated that all children born after January 1<sup>st</sup>, 1997 and enrolled in Grade Six, **will be required to receive a booster dose of the diphtheria, tetanus and pertussis vaccine (Tdap) as well as one dose of meningococcal vaccine.** Documentation that your child has received the required sixth grade immunizations must be turned into the school nurse no later than ***Thursday, September 4<sup>th</sup>, 2025***.

Students entering 6<sup>th</sup> grade with birthdays on or after **Thursday, September 4<sup>th</sup>, 2025** must provide written confirmation from your child's healthcare provider of the vaccination appointment. This appointment should be within two weeks of your child turning 11 years of age. The immunization record must be submitted immediately following the appointment. The Elizabeth Public School District is compelled by law to ensure that all students receive their required immunizations.

**Children who do not meet immunization requirements or do not have documentation of a scheduled appointment within two weeks of turning 11 years of age will be excluded from school beginning the first school day.**

#### **TRANSPORTATION**

Transportation will be available for the following students:

- Elementary students who live more than 2.0 miles from their school
- High school students who live more than 2.5 miles from their school
- Students whose IEP include transportation services
