Dear Parents/Guardians and Students,

We, the entire staff here at **Abraham Lincoln School No. 14**, are honored and elated to welcome all of our students and family members to the 2025-2026 school year ***beginning on Thursday, September 4th***! Our promise is to provide an innovative and personalized learning environment that ensures that every child achieves excellence. Within a safe, rigorous, and welcoming environment, we believe that every student can and will learn at his/her optimal level in order to reach their highest educational potential.

As a reminder, **Abraham Lincoln School 14 has an Annex** located at **416 Linden Avenue**. The building provides ten classrooms for second and third grade students, along with one fourth grade classroom.

The first day of school will begin on Thursday, September 4th, 2025, at 8:20 a.m. School is in session between the hours of 8:20 a.m. – 3:00 p.m. Please ensure that your child arrives and is picked up on time at school each day. Students in grades K-5 should *not* report to school before 8:20 a.m. daily. Students must be lined up with their homerooms at the designated entrance (information on other side). ***Important attendance update: any student arriving after 9:40am will be marked absent for the day. Any student dismissed prior to 1:40pm will be marked absent for the day.*** Students should not enter through the front door before 8:30 am. **Students in grades Kindergarten-5 will eat breakfast in their classrooms upon arrival at 8:20 a.m.** Middle school students can arrive as early as 7:45am to have breakfast through the gym/playground entrance. Please be reminded that Abraham Lincoln School No. 14 is a uniform school, which means **uniforms must be worn properly from the first day of school and every day thereafter**. Please see uniform information attached.

The 2025-2026 school year will begin on Thursday, September 4th, 2025. Instruction will be conducted during the hours of 8:20 a.m. to 3:00 p.m. In order to help facilitate both a smooth and orderly mode of transition during the times of arrival and dismissal, please adhere to the following safety procedures:

We ask that you guide and support your child's learning by ensuring that he/she attends school daily, arrives on time, and is ready for the day's learning experience.

POWERSCHOOL PARENT PORTAL INSTRUCTIONS

PowerSchool is an electronic management system that is utilized by the Elizabeth Public Schools in order to collect, store, and maintain pertinent student data and records. The application provides parents with real-time access to information that pertains to a student's schedule, attendance, grades, and academic progress; it also offers a convenient and accommodating way for both parents and teachers to communicate as needed. Therefore, everyone stays connected. Schedules for the upcoming 2025-2026 school year will be available to view on PowerSchool on *Monday, August 18th*.

NEW AND RETURNING PARENTS TO EPS

Parents of new students must request a new account in order to input all of the information required to navigate the PowerSchool Parent Portal. Parents of existing students will need to log in, input, and update any changed information that has occurred for their child.

UNIFORM POLICY

The intended purpose for the EPS dress code is to promote a positive self-image and to enhance school pride amongst our students. For the past few years, our school has operated as a 1:1 technology school; and as a result, all students will continue to utilize a *laptop computer* for their daily classroom instruction. Students should make every effort to take excellent care of their *laptops* throughout the school year, as this is a very special privilege. Our 1:1 technology implementation will continue to ensure that our students attain the competitive standards that are needed to foster both college and career readiness. *All students are required to bring their charged laptops and power cords to school daily.*

All new students to the district will receive their laptop during the first week of school.

NEW AND EXISTING PARENT INSTRUCTIONS

It is extremely important that we have the most updated home address and/or phone numbers so that we may contact you in the event of an emergency or to discuss your child's progress. Please be sure to update your contact information by logging into your PowerSchool Parent Portal and filling out the Emergency Information form found under the Forms link throughout the course of the school year should there be a change in either your home address and/or phone number. Open communication between the home and the school is expected and is one of the more pertinent keys to academic success in school.

Our Notification System enables staff members to contact parents through email, text, and through verbal messages recorded on the phone. Through this system, parents are immediately alerted of urgent information, major events, and/or upcoming dates. To ensure that this system will continue to operate in a highly effective manner, it is very important that we have ***the most current and accurate information on file for each and every student.***

IMMUNIZATION REQUIREMENTS

The state of New Jersey has mandated that all children born after January 1st, 1997 and enrolled in Grade Six, **will be required to receive a booster dose of the diphtheria, tetanus and pertussis vaccine (Tdap) as well as one dose of meningococcal vaccine.** Documentation that your child has received the required sixth grade immunizations must be turned into the school nurse no later than *Thursday, September 4th, 2025*.

Students entering 6th grade with birthdays on or after *Thursday, September 4th, 2025*, must provide written confirmation from your child’s healthcare provider of the vaccination appointment. This appointment should be within two weeks of your child turning 11 years of age. The immunization record must be submitted immediately following the appointment. The Elizabeth Public School District is compelled by law to ensure that all students receive their required immunizations.

Children who do not meet immunization requirements or do not have documentation of a scheduled appointment within two weeks of turning 11 years of age will be excluded from school beginning the first school day.

TRANSPORTATION

Transportation will be available for the following students:

- Elementary students who live more than 2.0 miles from their school
- High school students who live more than 2.5 miles from their school
- Students whose IEP include transportation services
