## FIRST DAY OF SCHOOL / ARRIVAL AND DISMISSAL PROCEDURES

The 2025-2026 school year will begin on Thursday, September 4<sup>th</sup>, 2025. Instruction will be conducted during the hours of 8:20 a.m. to 3:00 p.m. To help facilitate both a smooth and orderly mode of transition during the times of arrival and dismissal, please adhere to the following safety procedures:

#### **ARRIVAL:**

The first day of school, *Thursday*, *September*  $4^{th}$ , is a full day of school for all students within grades Pre-K - 8. Please keep in mind that we will operate on a regular day schedule:

• **Pre-Kindergarten** will enter directly into their TCU units and follow the directions on the map below.



- **Kindergarten** will enter through the front entrance and proceed directly to the classroom.
- 1st Grade Students will enter from the Monroe Avenue entrance and follow the directions on the enclosed map. 1st Grade Students will meet their teacher in the playground on Monroe Avenue. In case of inclement weather students will proceed to the Annex Gym.
- 2<sup>nd</sup> and 3<sup>rd</sup> Grade Students will enter from the front North Avenue entrance and follow the directions on the enclosed map. 2<sup>nd</sup> and 3<sup>rd</sup> grade students will meet their teacher in the Annex Gym for the first day of school.
- 4<sup>th</sup> and 5<sup>th</sup> Grade Students will enter through the Monroe Avenue entrance of the Main Building and follow the directions on the enclosed map.
- 6<sup>th</sup>, 7<sup>th</sup>, and 8<sup>th</sup> Grade Students will enter from the North Avenue entrance of the Main Building and follow the directions on the enclosed map.

#### **DISMISSAL:**

- **Pre-Kindergarten Students** will be dismissed at 2:55 p.m. from their TCUs.
- **Kindergarten Students** will be dismissed at 2:55 p.m. from their classroom.
- 1st Grade Students will be dismissed at 3:00 p.m. from the Monroe Avenue side of the building.
- 2<sup>nd</sup> and 3-B10 and 3-110 Students will be dismissed at 3:00pm from the front entrance of North Avenue.
- **Room 3-107** will exit from the side entrance near the Circle Garden on North Avenue at 3:00pm.
- Grades 4<sup>th</sup> and 5<sup>th</sup> will be dismissed from North Avenue Main Building at 2:55pm.
- **Grades 6<sup>th</sup> and 7<sup>th</sup>** will be dismissed from Monroe Avenue side of the building of Main Building at 3:00pm.
- Grade 8<sup>th</sup> will be dismissed from the Madison Avenue side of the building at 3:00pm.

NOTE: Parents, please wait for your child on the sidewalk and not in front of the entrance doorways or on the school steps. Please consider parking in the parking lot on Monroe Street. Please do not block the doors.

**BUSSED STUDENTS** will be called at 2:50 p.m. to board their buses.


It is imperative that students are picked up on time at the end of the day at 3:00 p.m.




- If necessary, please make prior arrangements as to whom will be responsible for your child at dismissal. Please indicate where your child should meet the designated individual so that he/she can be picked-up or walked home (form must be completed for walkers).
- Teaching and instruction are in session until 2:55 p.m. every day for students who are not boarding a bus.
- If your child must be picked up early, you must sign him/her out in one of the Main Offices and show proper identification. Remember that an early dismissal means that your child will miss some of his/her learning activity. All students, parents, and visitors must enter the building through the main entrance's security area of each building.

  Parents and visitors are required to sign in and show appropriate identification.

  Early dismissal will not be honored after 2:30 p.m.
- An older child who is responsible for picking-up a younger child must wait outside of the younger child's designated exit or decide on a mutual meeting place outside of the building.
- Please park your car appropriately and obey all traffic laws as specified; we do not want you to get a ticket or to be amid any kind of danger. North Avenue is often congested with both cars and trucks. Use the parking lot if necessary. Please do not double park.

### POWERSCHOOL PARENT PORTAL INSTRUCTIONS

PowerSchool is an electronic management system that is utilized by the Elizabeth Public Schools in order to collect, store, and maintain pertinent student data and records. The application provides parents with real-time access to information that pertains to a student's schedule, attendance, grades, and academic progress; it also offers a convenient and accommodating way for both parents and teachers to communicate as needed. Therefore, everyone stays connected. Schedules for the upcoming 2025-2026 school year will be available to view on PowerSchool on *Monday, August 18<sup>th</sup>*.

#### NEW AND RETURNING PARENTS TO EPS

Parents of new students must request a new account in order to input all of the information required to navigate the PowerSchool Parent Portal. Parents of existing students will need to log in, input, and update any changed information that has occurred for their child.

From there, please click on the "*PowerSchool Parent Portal Help*" tab. Please scroll down and click on the school that your child currently attends. You will then be directed to complete an online contact form. After clicking the *Save* and *Done* buttons at the bottom, your request will be submitted and someone from the school will be in contact with you as soon as possible.

#### **UNIFORM POLICY**

The intended purpose for the EPS dress code is to promote a positive self-image and to enhance school pride amongst our students. Health, safety, and educational well-being are the primary objectives for the dress code with the goal of fostering an environment that is conducive to discipline as well as to education. School uniforms are expected to be worn on a daily basis.

Students who do not adhere to the school uniform policy will not be permitted to enter the building on *Thursday*, *September 4*<sup>th</sup> or any school day thereafter. ### **ELECTRONIC DEVICES**

## Pre-K:

The implementation of iPads into the preschool classrooms provides an opportunity for our youngest students to extend their learning through developmentally appropriate active-learning experiences. While the iPad can serve as a tool to help reinforce skills in the areas of reading, writing and mathematics, it can also provide opportunities for preschool students to investigate, explore, and create within the early childhood setting.

The implementation of the iPad is integrated seamlessly into the preschool curriculum during center time. iPads enhance student learning by providing opportunities for students to retell and create their own stories, investigate and explore exciting new places and diverse cultures, capture their learning through student created portfolios, and reinforce skills through books and learning applications.

## K-8:

For the past few years, our school has operated as a 1:1 technology school; and as a result, all students will continue to utilize a <u>laptop computer</u> for their daily classroom instruction. Students should make every effort to take excellent care of their <u>laptops</u> throughout the school



year, as this is a very special privilege. Our 1:1 technology implementation will continue to ensure that our students attain the competitive standards that are needed to foster both college and career readiness. *All students are required to bring their charged laptops and power cords to school daily*.

## **NEW ENTRANTS**

All new students to the district will receive their laptop during the first week of school.

#### Please note:

- Bookbags, folders, binders, pencil cases, sweaters, etc. should be marked with the child's name in pen or marker.
- For the safe and effective operation of Madison-Monroe School No. 16, please refer to the policies and guidelines that are located on the EPS website at https://www.epsnj.org/Page/4374.
- Please check your child's agenda, bookbag and folder daily for homework assignments and important communications.
- Cell phones, IPods, AirPods, etc. ARE NOT PERMITTED to BE USED in the school building during instructional time.
- While it is understandable that many students have cell phones for emergency purposes, cell phones must be turned off and placed in the backpack. If a student has a cell phone in his/her possession (out of the backpack) beyond the front entrance, it will be confiscated. Parents will then be notified to retrieve the cell phone from the Principal's office. All 6-7-8 Grade Students will leave their bookbag with their cellphone in their designated area or locker during instructional time.
- Lockers, for students in Grades 7 and 8, are subject to search as in accordance with District Policy

## IMMUNIZATION REQUIREMENTS

## Pre-K:

Please be advised that the State of New Jersey, Department of Health Services, has changed several immunization requirements. All children attending licensed childcare centers and preschools are required to receive an annual flu vaccination.



Please provide proof of your child's required immunization as soon as possible and *no later than* **December 23**<sup>rd</sup>, 2025. Students who do not have the required documentation will be excluded from school as of **January 5**<sup>th</sup>, 2026.

## K-8:

The state of New Jersey has mandated that all children born after January 1<sup>st</sup>, 1997 and enrolled in Grade Six, will be required to receive a booster dose of the diphtheria, tetanus and pertussis vaccine (Tdap) as well as one dose of meningococcal vaccine. Documentation that your child has received the required sixth grade immunizations must be turned into the school nurse no later than *Thursday*, *September 4<sup>th</sup>*, 2025.

Students entering 6<sup>th</sup> grade with birthdays on or after *Thursday*, *September 4<sup>th</sup>*, *2025* must provide written confirmation from your child's healthcare provider of the vaccination appointment. This appointment should be within two weeks of your child turning 11 years of age. The immunization record must be submitted immediately following the appointment. The Elizabeth Public School District is compelled by law to ensure that all students receive their required immunizations.

Children who do not meet immunization requirements or do not have documentation of a scheduled appointment within two weeks of turning 11 years of age will be excluded from school beginning the first school day.

#### **TRANSPORTATION**

Transportation will be available for the following students:

- Elementary students who live more than 2.0 miles from their school
- High school students who live more than 2.5 miles from their school
- Students whose IEP include transportation services

- Lunch bills must be paid on time.
- Breakfast will be served daily for students in grades K-8 from 7:50 a.m. to 8:15 a.m. in both cafeterias in the Main and Annex Buildings. At 8:20 a.m., students in grades K-8 will orderly report to their classrooms.
- While students are welcomed to bring their own lunch to school, Madison Monroe School No. 16 *discourages the admittance of fast food within the school environment* because we are a Healthy Alliance School. We are also a *nut free school*.
- Birthdays are celebrated on a special Friday of each month, as noted on the school's monthly calendar.
