Dear Parents/Guardians and Students,

We, the entire staff here at **Robert Morris School No. 18**, are honored and elated to welcome all of our students and family members to the 2025-2026 school year ***beginning on Thursday, September 4th***! Our promise is to provide an innovative and personalized learning environment that ensures that every child achieves excellence. FIRST DAY OF SCHOOL / ARRIVAL AND DISMISSAL PROCEDURES

The 2025-2026 school year will begin on Thursday, September 4th, 2025. Instruction will be conducted during the hours of 8:20 a.m. to 3:00 p.m. In order to help facilitate both a smooth and orderly mode of transition during the times of arrival and dismissal, please adhere to the following safety procedures:

MORNING ARRIVAL PROCEDURES (8:20 A.M.):

NO PARKING IN FRONT OF THE SCHOOL. Student drop-off only.

Kindergarten- FIRST DAY ONLY: Students and their parents will meet their kindergarten teachers outside of school. Park your cars away from the front of the school. It is a NO PARKING ZONE that is used for student drop-offs.

Kindergarten- AFTER THE FIRST DAY: Students will enter the building through the main entrance. You may walk your child to school or use our student drop-off.

Grades 1, 2, and 3 – Students will enter the building through the main entrance.

Grades 4, 5, 6, 7, and 8 - Arriving between 7:50 a.m. - 8:20 a.m. - Students must enter through the side entrance (brown doors at the end of Durant Street) and report directly to the

cafeteria. Breakfast will be served from 7:50 a.m. - 8:20 a.m. Students reporting late (after 8:20 a.m.) must enter through the main entrance and sign in as tardy.

AFTERNOON DISMISSAL PROCEDURES (3:00 P.M.):

K-134, K-137- dismiss using their respective classrooms on Durant Street.

K-103- dismisses through room 137 on Durant Street.

K-102- dismisses using their classroom on the opposite side of Durant Street.

Grades 1 and 2- Playground- parents enter through the left side of the building (opposite side of Durant Street) and walk to the back of the building.

Grades 3 and 5 - 1st doors on Durant Street (near Cross Avenue).

Grade 4 - Left side of the building (opposite side of Durant Street)- **2nd doors**.

Grades 6, 7, and 8 - **Last Brown doors** near the end of Durant Street.

Late pick up – Walk around the build to playground and sign students out from the cafeteria.

PowerSchool is an electronic management system that is utilized by the Elizabeth Public Schools in order to collect, store, and maintain pertinent student data and records. The application provides parents with real-time access to information that pertains to a student's schedule, attendance, grades, and academic progress; it also offers a convenient and accommodating way for both parents and teachers to communicate as needed. NEW AND RETURNING PARENTS TO EPS

Parents of new students must request a new account in order to input all of the information required to navigate the PowerSchool Parent Portal. Parents of existing students will need to log in, input, and update any changed information that has occurred for their child.

IMMUNIZATION REQUIREMENTS

The state of New Jersey has mandated that all children born after January 1st, 1997 and enrolled in Grade Six, **will be required to receive a booster dose of the diphtheria, tetanus and pertussis vaccine (Tdap) as well as one dose of meningococcal vaccine.** Documentation that your child has received the required sixth grade immunizations must be turned into the school nurse no later than ***Thursday, September 4th, 2025.***

Students entering 6th grade with birthdays on or after ***Thursday, September 4th, 2025,*** must provide written confirmation from your child's healthcare provider of the vaccination appointment. This appointment should be within two weeks of your child turning 11 years of age. The immunization record must be submitted immediately following the appointment. The Elizabeth Public School District is compelled by law to ensure that all students receive their required immunizations.

Children who do not meet immunization requirements or do not have documentation of a scheduled appointment within two weeks of turning 11 years of age will be excluded from school beginning the first school day.

TRANSPORTATION

Transportation will be available for the following students:

- Elementary students who live more than 2.0 miles from their school
- High school students who live more than 2.5 miles from their school
- Students whose IEP include transportation services
