
Snowflakes for Sandy Hook Students


A Trip Through The Garden State

On with the Snow



ASSIGNMENT OF STUDENTS TO THE HIGH SCHOOLS

All Elizabeth resident students who wish to enroll in one of the district's high schools for the following year are required to complete on-line applications that will assist the district's administration in the placement process.

The dates for application submission will be published each year and all applications must be submitted within the timeframe indicated. **Only online applications will be accepted.** Prior to the application period, information sessions will be held at each high school and interested parents/guardians and students will be invited to attend any or all of these sessions.

Fulfilling student requests for specific high school and strand placement will depend strictly on program capacity and the established program requirements for each high school. No student attending the Elizabeth Public Schools shall be denied access to, or benefit from, any educational or vocational program solely on the basis of race, creed, color, national origin, ancestry, age, gender, place of residence within the district, socioeconomic status, or disability.

An application will be considered to have been submitted successfully only when the following steps have been completed:

- The application essay <u>and</u> the listing of six high school selections in order of personal preference are submitted on-line as directed;
- The confirmation page indicating successful submission of the above information is printed in hard copy format;
- The confirmation page is signed by the student <u>and his/her parent/guardian;</u>
- The signed confirmation page is returned by all Elizabeth Public Schools students to the school each student is currently attending.
- **Non-public school students** who are Elizabeth residents must return this confirmation page to the attention of:

Notification of high school assignments will be sent no later than July 1st to all students who submitted completed applications as described above and did so within the stated timeframe.

Established Guidelines for Alexander Hamilton Preparatory Academy, Thomas Jefferson Arts Academy, and Elizabeth High School

- The **Alexander Hamilton Preparatory Academy** will only admit students with a grade point average of 2.0 or higher and who are committed to preparing for post-secondary education.
- Applicants to the **Thomas Jefferson Arts Academy** will be required to either audition or submit a portfolio (according to his/her personal area of skill/interest) in order to be considered for enrollment.
- Students who wish to enroll at **Elizabeth High School** must possess and agree to maintain at least a 3.0 grade point average, demonstrate academic potential, and comply with a rigorous college preparatory course sequence that includes, but is not limited to, Advanced Placement courses and examinations, the study of Latin, and the completion of a senior project. The "demonstration of academic potential" is determined by combining the current summative assessment scores in language arts literacy and mathematics and the student's current grade point average according to the formula outlined below:

GPA + Current Summative Assessment Score in Language Arts + Current Summative Assessment Score in Mathematics = Eligibility Score

Placement of Students in Respective High Schools

- Students who apply to **Elizabeth High School** <u>as their first choice</u> will be ranked according to their eligibility indices. Incoming students with the highest indices will be assigned to Elizabeth High School until all available seats at their respective grade levels are filled.
- Students who apply to **Alexander Hamilton Academy** <u>as their first choice</u> will be ranked according to their GPA. Incoming students with the highest GPA scores will be assigned to Alexander Hamilton Academy until all available seats at their respective grade levels are filled.
- Students who apply to **Thomas Jefferson Arts Academy** as their first choice school will be placed in accordance with the proficiency noted during their audition or portfolio presentations.
- Students who apply to any of the high schools listed above as their first choice school and meet all of the high school specific requirements will be given first consideration for placement in that school. The same will hold true for students who list John E. Dwyer Technology Academy, Admiral William F. Halsey, Jr. Leadership Academy, or Thomas A. Edison Career and Technical Academy as their first choice schools.

• If an eligible student cannot be accommodated in his/her first choice school because the school's capacity at the requested grade level has been reached, the student will be placed on a waitlist for that school and the second choice school will be assigned if this is at all possible. If not possible because the school capacity has been reached, the third choice school will be assigned and so on through the sixth choice until the student is assigned to a high school.

For both Elizabeth High School and Alexander Hamilton Preparatory Academy, there are exceptions to this process as described below:

- If an eligible student lists Elizabeth High School as his/her first choice and does not get assigned to this school because all available seats at his/her respective grade level have, in keeping with the stated selection process, been filled, the student will not automatically be placed in his/her second choice school if that second choice is Alexander Hamilton Preparatory Academy. All students who list Alexander Hamilton Preparatory Academy as their top choice and meet the specific requirements for this school will be given priority for placement at Alexander Hamilton Preparatory Academy.
- If an eligible student who lists Alexander Hamilton Preparatory Academy as his/her first choice does not get assigned to this school because all available seats at his/her respective grade level have, in keeping with the stated selection process, been filled, the student will not automatically be placed in his/her second choice school if that second choice is Elizabeth High School.
- If it is the parents'/guardians' wish, a student who is not accepted into Elizabeth High School due to space constraints and who has listed Alexander Hamilton Preparatory Academy as his/her second choice may request to be placed on the waiting list for <u>both</u> Elizabeth High School and for Alexander Hamilton Preparatory Academy. Consequently, if it is the parents'/guardians' wish, a student who is not accepted into Alexander Hamilton Preparatory Academy due to space constraints and who has listed Elizabeth High School as his/her second choice may request to be placed on the waiting list for <u>both</u> Alexander Hamilton Preparatory Academy and for Elizabeth High School.

Request for Changes in High School Assignment

- Any request for a change in a high school assignment <u>must</u> be made prior to October 15th of each school year. No requests for changes will be considered after this date except in the case of extraordinary circumstances.
- A parent/guardian wishing to have his son or daughter moved to another high school must first submit a formal letter to the Assistant Superintendent in charge of high schools at 505 North Broad Street, Elizabeth, NJ 07208. The letter must indicate the change being requested and describe in detail the significant reason for the request.

- The Assistant Superintendent in charge of high schools will review the letter, determine the appropriateness of the request, review the student's school records in terms of eligibility for the high school requested, and then check on the availability of seats at the school, grade level, and within the career strand requested.
- The Assistant Superintendent in charge of high schools will communicate with the principals of the high schools involved and ensure there are no issues that might make this change in schools impractical or unworkable.
- The final decision on whether the request for a change in schools will be permitted will be made by the Assistant Superintendent in charge of high schools, who will be responsible for notifying all involved parties and setting up a date for the actual transfer, if this is the decision that has been reached.
