"Up On a Housetop"



WHEREAS, the Secretary-School Business Administrator has certified that sufficient funds are available and appropriated for this purpose.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Education of the City of Elizabeth, as follows:

- 1. That the President and Secretary of the Board be authorized to execute a contract with The Education Law Center, Inc., 60 Park Place, Newark, New Jersey 07102, for the purpose of providing advice and assistance on legal matters concerning public school education for a period one year, commencing at the signing of the contract, at a cost not to exceed \$24,870.00.
- 2. The contract is awarded without competitive bidding for "Professional Services" in accordance with N.J.S.A. 18A:18A-5a(1) of the Local Public School Contracts Law because The Education Law Center, Inc., performs legal services through the auspices of licensed attorneys-at-law, whose practice is authorized and regulated by law and is exempted by the provisions of the Local Public School Contracts Law.

- 1. I will uphold and enforce all laws, state board rules and regulations, and court orders pertaining to schools. Desired changes should be brought about only through legal and ethical procedures.
- 2. I will make decisions in terms of the educational welfare of children and will seek to develop and maintain public schools which meet the individual needs of all children regardless of their ability, race, creed, sex, or social standing.
- 3. I will confine my board action to policymaking, planning and appraisal, and I will help to frame policies and plans only after the board has consulted those who will be affected by them.
- 4. I will carry out my responsibility, not to administer the schools, but, together with my fellow board members, to see that they are well run.
- 5. I will recognize that authority rests with the board of education and will make no personal promises nor take any private action which may compromise the board.
- 6. I will refuse to surrender my independent judgment to special interest or partisan political groups or to use the schools for personal gain or for the gain of friends.
- 7. I will hold confidential all matters pertaining to the schools, which, if disclosed, would needlessly injure individuals or the schools. But, in all other matters, I will provide accurate information and, in concert with my fellow board members interpret to the staff the aspirations of the community for its schools.
- 8. I will vote to appoint the best qualified personnel available after consideration of the recommendation of the Chief Administrative Officer.
- 9. I will support and protect school personnel in proper performance of their duties.
- 10. I will refer all complaints to the Chief Administrative Officer and will act on such complaints at public meetings only after failure of an administrative solution.

CHIEF SCHOOL ADMINISTRATOR

The Board of Education, in compliance with State law, will evaluate the Chief School Administrator at least annually. Every newly appointed or elected Board member shall complete the New Jersey School Boards Association's training program on evaluation of superintendents within six months of commencement of his/her term of office.

The most important fundamental responsibility of the Elizabeth Board of Education is the employment of the Chief School Administrator. As the governance team, the Board and the Chief School Administrator hold themselves accountable for the continuous improvement of the Elizabeth Public Schools. The Board is responsible for defining success for the Elizabeth Public Schools by formulating policies for the operation of the district and for ensuring that the Chief School Administrator effectively manages the school district through successful implementation of these policies. As such, the Elizabeth Board of Education commits to an ongoing process of evaluating the Chief School Administrator's performance throughout the year with honest discussions between the Board members and the Chief School Administrator regarding the performance of the Elizabeth Public Schools.

This policy sets forth standards and describes processes. It is the intention of the Elizabeth Board of Education to meet the standards and follow these processes, but from time to time, by decision of the Board President and the Chief School Administrator, processes and timelines may vary. The standards and processes are not intended to be overly restrictive or become issue of dispute, but rather guidelines for effective and meaningful evaluation of the Chief School Administrator.

The purpose of the evaluation shall be to:

- A. Promote professional leadership excellence and improve the skills of the Chief School Administrator;
- B. Improve the quality of the education received by the students served by the Elizabeth Public Schools;
- C. Provide constructive feedback on the Chief School Administrator's job performance, the intent being the continuous improvement of the Elizabeth Public Schools;
- D. Clarify and align the expectations of the Board and the Chief School Administrator with the district's Vision, Mission, Core Beliefs and Commitments, and Theory of Action.

Role and Responsibility of the Board

The role and responsibility of the Board in this evaluation shall be to:

- A. Complete a New Jersey School Boards Association training program on the evaluation of the Chief School Administrator within six months of the commencement of newly appointed or elected district board member's term of office (N.J.S.A. 18A:17-20.3b; see Board Policy Orientation and Training of Board Members File Code 9200);
- B. Review, revise and adopt procedures suggested by the Chief School Administrator for implementation of this policy;
- C. Determine whether the services of a qualified consultant will contribute substantially to the evaluation process, and may engage such a consultant as deemed appropriated to assist the Board. The evaluation itself shall be the responsibility of the Board;
- D. Adopt an individual plan for professional growth and development of the Chief School Administrator based in part upon any needs identified in the evaluation. This plan shall be mutually developed by the Board and the Chief School Administrator. The duration of the plan will be three to five years, depending on the Chief School Administrator's contract with the school district;
- E. Hold an annual summary conference between a majority of its total membership and the Chief School Administrator. The annual summary conference shall be held before the written performance report is filed. The conference shall be held in private, unless the Chief School Administrator requests that it be held in public. The conference shall include, but not be limited to, review of the following:
 - 1. Performance of the Chief School Administrator based upon the job description;
 - 2. Progress of the Chief School Administrator in achieving and/or implementing the school district's goals, program objectives, policies, instructional priorities, State goals, and statutory requirements; and
 - 3. Indicators of student progress and growth toward program objectives.
- F. Each Board member will complete the Superintendent of Schools Annual Performance Report and may meet individually with the Chief School Administrator to deliver and discuss the completed evaluation. Board members must consult the Board Attorney to ensure compliance with ethical standards in advance of the evaluation and consultation meeting process. After all Board members complete their individual written evaluation of the Chief School Administrator, the Board President will collect all individual written evaluations and create a master Performance Report document compiling the average scores and comments from the individual evaluations and review the report with the Chief School Administrator. In addition, all individual evaluation documents must be provided to the Chief School Administrator;

- G. Prepare by July 1, subsequent to the annual summary conference, an annual written performance report, approved by a majority of the full membership of the Board. This report shall include:
 - 1. Performance areas of strength;
 - 2. Performance areas needing improvement based upon the job description and evaluation criteria set forth in "E" above;
 - 3. Recommendations for professional growth and development;
 - 4. A summary of available indicators of student progress and growth and a statement of how these available indicators relate to the effectiveness of the overall program and the performance of the Chief School Administrator;
 - 5. A summary of key indicators of system performance aligned with the Elizabeth Public Schools Data Dashboard;
 - 6. Provision for performance data which have not been included in the report prepared by the Board of Education to be entered into the record by the Chief School Administrator within ten (10) working days after the completion of the report.
- H. To add all written performance reports and supporting data, including, but not limited to, indicators of student progress and growth to a Chief School Administrator's personnel file. The records shall be confidential and not be subject to public inspection or copying pursuant to the Open Public Records Act, N.J.S.A. 47:1A-1 et seq.

Role and Responsibility of the Chief School Administrator

The Board shall determine the role and responsibility in consultation with the Chief School Administrator. The Chief School Administrator shall provide information and propose procedures for:

- A. Development of a job description and evaluation criteria, based upon the district's local goals, program objectives, policies, instructional priorities, State goals, statutory requirements, and the functions, duties and responsibilities of the Chief School Administrator. The evaluation criteria shall include but not be limited to available indicators of student progress;
- B. Specification of methods of data collection and reporting appropriate to the job description;
- C. Design of evaluation instruments suited to reviewing the Chief School Administrator's performance based upon the job description;

- D. Establishing an evaluation calendar to include a date for the annual conference and including appropriate information to allow proper consideration of all the items to be included in the subsequent written performance report;
- E. At least fourteen days (14) prior to the Board's formal evaluation, the Chief School Administrator will submit to the Board a Self-Appraisal, which shall address the following:
 - 1. Performance Summary Letter
 - 2. Accomplishments Report
 - 3. Student Achievement Report
 - 4. District Information
 - 5. Goals and Performance Measurements Report

Each Board member will receive a copy of the Chief School Administrator's Self-Appraisal which will be used in completing the evaluation of the Chief School Administrator.

- F. After the Board's adoption of the annual written performance report, to provide all other appropriate information relative to evaluation of his/her performance not contained in the report;
- G. Preparation and review of the Professional Growth Plan for the administrator's professional development.

The policy shall be delivered to the Chief School Administrator upon adoption. Amendments to the policy shall be distributed within ten (10) working days after adoption. The policy shall be reviewed annually in the month of January.
