Parents Become the Students at Terence C. Reilly



WHEREAS, the Board believes that public meetings should be held in a manner which will provide the Board with a greater opportunity to receive information and discuss matters to come before the Board in advance of Board action; and

WHEREAS, the Board is of the opinion that the goal of providing its members and the public with more information and a better understanding of the matters to be considered and voted upon by the Board at the monthly business meeting can be best achieved through the scheduling of a monthly public agenda setting meeting at which the administrators of the Elizabeth Public School District and others can present information regarding items proposed for consideration by the Board and the Board can discuss such issues in advance of the regular Board meeting.

NOW, THEREFORE, BE IT RESOLVED that the Board of Education hereby determines that beginning February 2017 it will schedule a regular monthly public agenda meeting to be held one week prior to the regular monthly meeting of the Board; and

BE IT FURTHER RESOLVED that at such agenda setting meeting the members of the Board sitting as a Committee of the Whole will receive, consider and discuss information concerning items proposed for approval of the Board and will determine if such items should be placed on the agenda for a vote by the Board at the regular Board meeting the following week; and

BE IT FURTHER RESOLVED that the Superintendent and such personnel as she may designate shall establish a process and procedure, including fixed deadlines, for submission of items to be reviewed by the Board. At the Board meeting in January 2017 the Board will establish a schedule of agenda setting meetings for the balance of 2017.
