He told the students that instead of describing themselves with words like intelligent, artistic, and athletic, many unfortunately tend to choose words like fat, ugly, and stupid. "A high level of self-esteem... I didn't make that choice till I was 27...I hope victims will say 'Enough is enough'...Know that there is help."

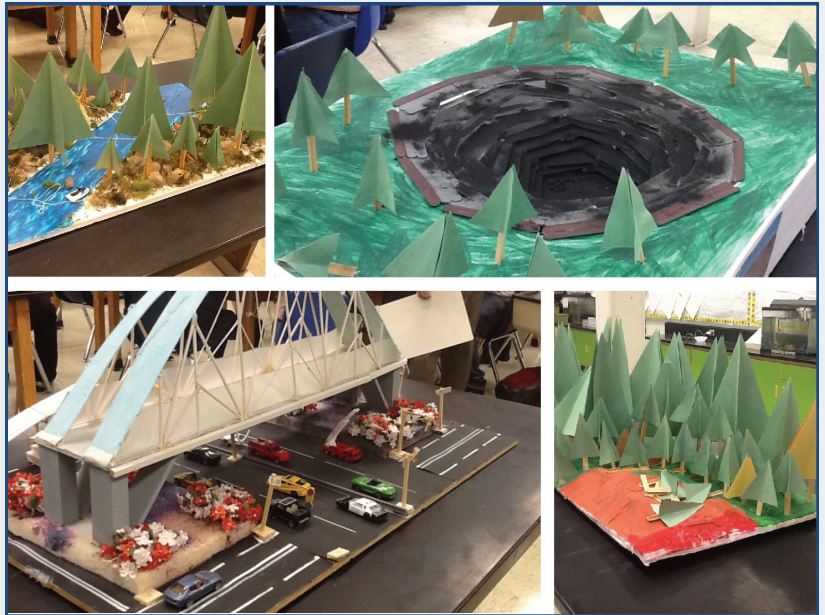
Beep! Beep!

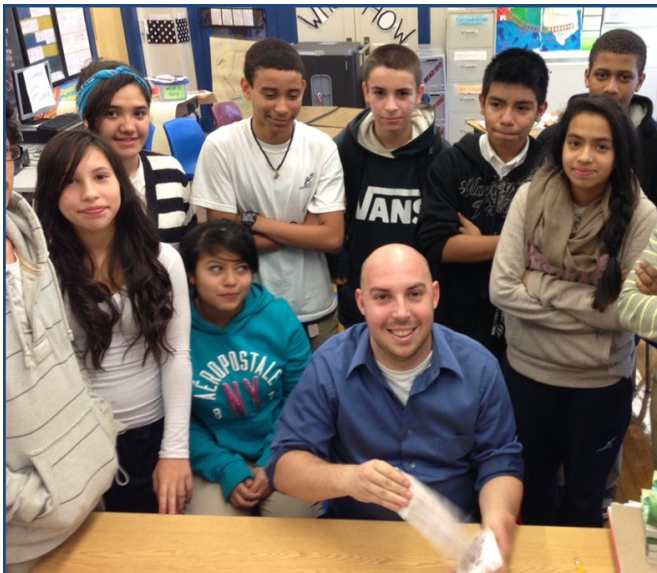
American Education Week Spelling Contest
