

WHEREAS, School District of Elizabeth ("District") policy, state and federal law provide that a child's enrollment in public school may not be conditioned on the child's immigration status; and

WHEREAS, public schools may not inquire regarding the immigration status of a student or the student's parent (s) guardian (s) as part of the admissions process; and

WHEREAS, the District works to foster welcoming and safe school environments for all students, including those who may be undocumented or have undocumented family members; and

WHEREAS, the Board recognizes the potential for U.S. Immigration and Customs Enforcement (ICE) officials to engage in enforcement efforts to detain undocumented individuals, and that such efforts may result in ICE officials seeking to enter upon school grounds for purposes of enforcement; and

WHEREAS, ICE activities in and around schools, early childhood centers and other District facilities would risk disruption to the learning environment; and

WHEREAS, the Board, by adopting the within Resolution, intends to reaffirm its commitment to policies that seek to avoid such disruption and interference with the education of District students.

NOW, THEREFORE, BE IT FURTHER RESOLVED by the Board of Education of the City of Elizabeth School as follows:

- 1. All requests made of the District.or its schools by ICE officials to access information or school grounds shall be processed through the Office of the Superintendent, to ensure compliance with the law. Schools shall not permit ICE officials to access students at school without having first contacted and processed their request and all relevant documentation through the Office of the Superintendent.
- 2. District staff shall continue to treat all students in an equitable manner without regard for race, ethnicity, immigration status, or national origin.
- 3. District staff shall not inquire about a student's immigration status, or the immigration status of the student's parent(s), guardian(s) or family members.

RESOLUTION

STUDENT ADVISORY COMMITTEE

WHEREAS, the Student Advisory Committee is a council of students from each High School in the District.

WHEREAS, the Student Advisory Committee shall work to increase the engagement and involvement of the student body in educational affairs.

WHEREAS, each high school shall have two representatives to serve on the Student Advisory Committee on a yearly basis.

WHEREAS, it shall be the responsibility of each individual high school student government to provide for the election of two representatives from each High School to serve on the Student Advisory Committee

WHEREAS, eligibility to serve on the Student Advisory Committee shall be open to all Juniors and Seniors of each High School.

WHEREAS, it shall be the responsibility of an assigned Student Advisory Committee Advisor to convene a minimum of four formal quarterly meetings with the entire Student Council Committee.

WHEREAS, elections for the 2016-2017 School year shall commence during the month of March 2017 with a formal meeting of the Student Advisory Committee to occur no later than May 2017.

BE IT FURTHER RESOLVED, that copies of this resolution be forwarded to all High School Principals in the Elizabeth Public Schools to encourage the creation and development of the Student Advisory Committee.
