




# **Scholar Awards Ceremony**

## Reading Under the Stars



- C. Provide an honest, continuous, comprehensive flow of information about the policies, procedures, programs, problems and progress of the school system to the community and the staff;
- D. Develop the most effective means of communication with the school system's public and use available media as appropriate;
- E. Develop programs in the schools that will integrate home, school, and community in meeting the needs of district students;
- F. Develop and maintain the confidence of the community in the school board and the school staff;
- G. Develop a climate that attracts good teachers and encourages staff to strive for excellence in the educational program;
- H. Anticipate and forestall problems that are brought about by lack of understanding;
- I. Evaluate past procedures in order to make improvements in future communications.

The Chief School Administrator shall be responsible for developing programs, techniques and channels for implementing this policy.

### SPECIAL EDUCATON PARENT ADVISORY COMMITTEES

Parent involvement is the important backbone of our school system. In order to provide a mechanism by which the parents of students with disabilities are involved in the decision-making process, the Board of Education shall create a special education parent advisory committee that will provide recommendations on issues regarding special education programming in the District. The special education parent advisory committee (SEPAC) is strictly advisory in nature and will provide recommendations that the Board of Education will take into consideration.

At the time the SEPAC is established, the Board of Education shall review and approve the following:

- A. The purpose and responsibility of the committee;
- B. The scope and duration of the committee's operation;
- C. The committee membership, in terms of appropriate community representation, total number of members, method of selection, and length of terms;
- D. The time and means of reporting the committee's findings and recommendations to the Board of Education.

The Superintendent will create a regulation of each committee's charge that will be presented to the Board of Education for approval.

## A. Purpose and Responsibility of the Committee

The Elizabeth Board of Education Special Education Parent Advisory committee (ESEPAC) exists to fulfill the requirements of the New Jersey Administrative Code 6A:14-1.2(h):

Each Board of Education shall ensure that a special education parent advisory group is in place in the district to provide input to the district on issues concerning students with disabilities.

The ESEPAC works collaboratively with all Special Education parents and District staff in an advisory capacity to the Elizabeth Board of Education to:

- Foster increased communication of services and information for families of children with special education needs;
- Facilitate and foster parent involvement in parent education resources;
- Foster and promote inclusionary special education settings for all students;
- Provide advisory information to the Elizabeth Board of Education of issues pertaining to special education services in the district; and
- Provide information meetings on topics of interest for families with students who receive special education and/or educational support services.

# B. Scope and Duration of the Committee's Operation

The committee will be a standing committee to meet the requirements of State Code 6A:14-1.2(h). The committee's scope is limited to the purpose and responsibility of the committee as detailed in Section A., and serves in an advisory capacity to the Elizabeth Board of Education.

### C. Committee Membership

The Committee will be comprised as follows:

- 2 parents with a child in an elementary school, 1 parent recommended by a principal and 1 parent recommended by the PTA/PTO
- 2 parents with a child in a middle school, 1 parent recommended by a principal and 1 parent recommended by the PTA/PTO
- 2 parents with a child in a high school, 1 parent recommended by a principal and 1 parent recommended by the PTA/PTO

- At least 2 parents with students in out-of-district placement 1 parent recommended by the Director of Special Education and 1 parent recommended by the PTA/PTO
- Supervisor of Special Education (non-voting member)
- Director of Special Education (non-voting member)
- Elizabeth Board of Education liaison or Superintendent representative (non-voting member)

The names will be forwarded to the Director of Special Education no later than June 15th of each year with review by the Board of Education during their July voting meeting.

# D. Reporting to the Elizabeth Board of Education

Written agendas, minutes and a summary of the year's activities of all committee meetings should be shared with the Director of Special Education and/or the Superintendent/representative. At least once a year, and more often if needed, the committee will meet with the Board and/or Board committee in a workshop meeting to provide an overview of the work of the committee and provide input to the Board on issues critical to Special Education.

### CONSTITUENT SERVICE

The purpose of this policy is to respond to constituent inquiries, issues, concerns, questions, compliments and comments, addressed to the Board for resolution and for use in systemic improvements.

The Board of Education recognizes that its ability to service requests in an efficient, timely and courteous manner is a critical component necessary to promote continuous system improvement, to inform, educate and to support the needs of the Elizabeth Public Schools. As elected officials acting on behalf of the children, parents and taxpayers, the Elizabeth Board of Education Board members' role in constituent service is to facilitate management's ability to resolve problems effectively without becoming involved themselves in directly solving problems or handling management issues. All Elizabeth Board of Education Board members will be trained on an annual basis on this policy. All new Elizabeth Board of Education Board members will be trained following the annual Reorganization meeting as part of the induction process.

### Defining Constituent Service

Constituent service is defined as ensuring that management takes responsibility for providing residents the services they rightfully should receive from their elected school Board representatives and employees of the Elizabeth Public Schools. The following definitions apply:

- <u>Constituents</u> are residents of the community who are represented by elected Elizabeth Board of Education members. Constituents include students, parents, guardians, employees with children in the district, taxpayers and members of the community.
- Governance is the primary role of the elected Elizabeth Board of Education members.
   Governance involves ensuring the delivery of required educational and support services in the District by providing oversight and policy to the Superintendent regarding those services and desired results. Governance is strategic and involves the development of policy focused on effecting system improvement.
- Management is the responsibility of the Superintendent who is an employee of the Elizabeth Public Schools and operates within District policy established by the Elizabeth Board of Education and all applicable local, state and federal laws and regulations. Management includes directing staff, allocating resources, administering programs and providing support services to improve school system effectiveness and successfully achieve District objectives.
- Appropriate Constituent Service ensures that management takes responsibility for helping
  constituents receive the services that the Elizabeth Public School system provides, using the
  resources provided for those services.

Inappropriate Constituent Service is defined as Board Member involvement in management or
delivery of specific services or desired results, even if the problem is serious and/or the Board
member's involvement is minimal. This ensures that Board Members do not confer special
advantage on staff, parents, students, vendors or any other person or entity outside regular
decision-making processes established by policy or management to ensure fairness and equity.

### System for Constituent Service

The system for handling constituent services requests is based on the establishment of a reliable communication mechanism between the Elizabeth Board of Education members and the Superintendent that will refer, track, and resolve constituent inquiries. Inquiries in the form of written correspondence, e-mail, or telephone will be managed by electronic means to facilitate communication and record-keeping in the system. Requests will be tracked in the system by category of request, date of response, and a summary of the response (at a minimum). This information will be maintained in a consolidated database until reviewed by the Board and Superintendent.

Constituent requests received by the Elizabeth Board of Education members will be forwarded to the Superintendent's designee to be logged into the Elizabeth Public Schools Direct ("EPSDirect") tracking system. The Superintendent's designee will refer the request to the appropriate department for action. Upon department response and review by the Superintendent's designee, the District response will be logged into the EPSDirect tracking system to ensure that all Board Members are advised of the action on the constituent's request, keeping the constituent advised of the status, and updating the request in the system.

For requests that come to the Board which have not followed internal protocol for escalation to the Board, Board members may respond in the following ways:

- 1. Provide information (if known)
- 2. Refer the constituent to the appropriate office
- 3. Refer the issue to the Superintendent
- 4. Request a response from the Superintendent to be drafted on behalf of the Board

The Board and the Superintendent shall establish written protocols for the above processes and will review the protocols annually.

### Protocol for Constituent Service

The protocol begins with a constituent's request to a Board member for information and/or assistance. If the request is for information, the Board member should provide the information (if known) or explain to the constituent where or from whom this information should be obtained.

If the constituent requests assistance in addressing an issue or problem, the Board member must first evaluate the validity of the claim and also determine if the constituent is an employee of the Board with an employment issue. If the request or the complaint appears to be valid and is urgent, complicated, or has potential for major consequence, the Board member should refer the request to the Superintendent's designee for administrative action. Further, if the constituent is an employee of the Board with an employment issue, the Board member should refer the constituent to follow the district's chain of command through administration.

If the request or issue is not urgent, then the Board member should explain to the constituent the district's chain of command, clarify the difference between governance and management, and define the Board's role in constituent service. The Board member should then direct the constituent back into the system, that is, to talk to the teacher or principal, transportation office, etc. The Board member may need to provide the constituent with contact information. The constituent should be invited to call the Board member again if a timely response is not received from the district staff.

If the constituent does not receive a satisfactory response despite good faith efforts to resolve the issue with management, the issue should be referred to Board services, which will then take appropriate administrative action.

For every issue, referred to the superintendent's designee, Board members will receive a written report on the manner and timeframe of issue resolution. If the issue is significant or requires time to resolve, the superintendent's designee will notify the Board member regarding the plans, steps taken, and the time frame for resolution.

The superintendent's designee is responsible for briefing the superintendent as needed and for preparing periodic reports for the superintendent and full Board showing:

- Request patterns
- System issues, and
- Work to date to improve systems.

The Board and superintendent should review the effectiveness of the constituent service system from time to time and make the necessary changes and adjustments. The Board members will honor the spirit of the constituent service policy in order to ensure consistent, reliable, and effective responses to requests for information or assistance presented to individual Board members.

# Guidelines for Responding to Constituent Requests

The Board will implement a constituent services system, which will accomplish the following:

- 1. Track and monitor the progress for responding to issues and requests,
- 2. Archive, categorize and analyze requests and responses,
- 3. Produce reports for analysis and review by the Board on a quarterly basis, and
- 4. Provide a mechanism for quality assurance.

### The Board expects this system to result in:

- 1. All e-mails and letters will be responded to within 5 business days,
- 2. Phone calls will be returned immediately whenever practicable and no later than two business days,
- 3. Human interaction will be used whenever possible, and the use of voice mail will be minimized,
- 4. A database of resolved issues will be used to increase efficiency throughout the school district, and
- 5. The ability of the administration to make system improvements based on identified patterns will be increased.

### Reporting and System Improvement

The Board directs the Superintendent to establish appropriate administrative procedures to implement this policy. Quarterly reports will be provided that include constituent service request data, trends, conclusions and recommendations for improvement. The Superintendent's report to the Board will be in a suitable electronic document and include data and graphs portraying the results and processes involved. This report will contain the most current information, and will also include comparative data and trend analyses. Constituent services responses will be included in the District's Data DashBoard for systemic monitoring and evaluation.

### SPORTS RELATED CONCUSSION AND HEAD INJURY

A concussion is a traumatic brain injury (TBI) caused by a direct or indirect blow to the head or body.

### Requirements

- A. A student who participates in interscholastic athletics, which for the purpose of this policy includes cheerleading, and who sustains or is suspected of sustaining a concussion or other head injury shall be immediately removed from the competition or practice. The student-athlete or cheerleader may not return to play until they obtain medical clearance in compliance with the district return-to-play policy;
- B. All coaches, school nurses, school/team physicians and certified athletic trainers must complete an interscholastic head injury training program such as the National Federation of State High School Associations online "Concussions in Sports" training program or a comparable program that meets mandated criteria;
- C. The district shall monitor school district employees in the completion of an interscholastic head injury training program;
- D. The athletic head injury training program must include:
  - 1. The recognition of the symptoms of head and neck injuries, concussions, and injuries related to second impact syndrome; and
  - 2. Describe the appropriate time to delay the return to sports competition or practice of a student-athlete who has sustained a head injury or other head injury, but if no additional time is specified for a particular age-group or sport, the student-athlete may return when written medical clearance is given the student-athlete stating that he/she is asymptomatic, and the student-athlete has completed an appropriate graduated individualized return-to-play protocol.
- E. Distribution of New Jersey Department of Education, *Concussion and Head Injury Fact Sheet* to every student-athlete who participates in interscholastic sports. The Chief School Administrator shall ensure that a signed acknowledgement of the receipt of the fact sheet is completed by the student-athlete's parent/guardian and is kept on file for future reference.

## Required Concussion Protocol

A student-athlete who is suspected of sustaining a sports related concussion or other head injury during competition or practice shall be immediately removed from play and may not return to play that day.

- A. Possible signs (could be observed by coaches, athletic trainer, school/team physician, school nurse):
  - 1. Appears dazed, stunned, or disoriented;
  - 2. Forgets plays, or demonstrates short term memory difficulty;
  - 3. Exhibits difficulties with balance or coordination;
  - 4. Answers questions slowly or inaccurately;
  - 5. Loses consciousness;
- B. Possible symptoms (reported by the student-athlete to coaches, athletic trainer, school/team physician, school nurse, parent/guardian):
  - 1. Headache;
  - 2. Nausea/vomiting;
  - 3. Balance problems or dizziness;
  - 4. Double vision or changes in vision;
  - 5. Sensitivity to light or sound/noise;
  - 6. Feeling sluggish or foggy;
  - 7. Difficulty with concentration and short term memory;
  - 8. Sleep disturbance.
- C. To return to competition and practice the student-athlete must follow the protocol:
  - 1. Immediate removal from competition or practice;
  - 2. School personnel (athletic trainer, school nurse, coach, etc.) should make contact with the student-athlete's parent/guardian and inform them of the suspected sports-related concussion or head injury;
  - 3. School personnel (athletic trainer, school nurse, coach, etc.) shall provide student-athlete with the approved information/medical checklist to provide their parent/guardian and physician or other licensed healthcare professional;
  - 4. Student-athlete must receive written clearance from their physician that student is asymptomatic and may begin the graduated return-to-play protocol. School personnel (athletic trainer, school nurse, coach, etc. may consult with school/team physician after medical clearance is given from student-athletes physician).

## Graduated Return to Competition and Practice Protocol

A. After written medical clearance is given stating that the student-athlete is asymptomatic, the student-athlete may begin a graduated individualized return-to-play protocol:

- **Step 1:** No activity, complete physical and cognitive rest. The objective of this step is recovery;
- **Step 2:** Light aerobic exercise, which includes walking, swimming, or stationary cycling, keeping the intensity less than 70% maximum percentage heart rate; no resistance training. The objective of this step is increased heart rate;
- **Step 3:** Sport-specific exercise including skating and/or running; no head impact activities. The objective of this step is to add movement;
- **Step 4:** Non-contact training drills (e.g. passing drills). The student-athlete may initiate progressive resistance training;
- Step 5: Following medical clearance (consultation between school personnel and studentathlete's physician), participation in normal training activities. The objective of this step is to restore confidence and assess functional skills by the coaching staff;
- Step 6: Return to play involving normal exertion or game activity.
- B. Symptom checklists, baseline testing and balance testing may be utilized;
- C. If the student-athlete exhibits a re-emergence of any post-concussion signs or symptoms once he or she returns-to-play, they will be removed from exertional activities and returned to their school/team physician or primary care physician;
- D. If concussion symptoms re-occur during the graduated return-to-play protocol, the student-athlete will return to the previous level of activity that caused no symptoms.

# Temporary Accommodations for Student-Athletes with Sports Related Head Injuries

- A. Consideration of the cognitive effects in returning to the classroom is also an important part of the treatment of sports related concussions and head injuries;
- B. Mental exertion increases the symptoms from concussions and affects recovery;
- C. To recover, cognitive rest is just as important as physical rest. Reading, studying, testing, texting, even watching movies if a student is sensitive to light can slow down a student's recovery;
- D. In accordance with the Centers for Disease Control and Prevention toolkit on managing concussions, the board of education may look to address the students' cognitive needs in the following ways;

- E. Students who return to school after a concussion may need to:
  - 1. Take rest breaks as needed, including physical education;
  - 2. Spend fewer hours at school;
  - 3. Be given more time to take test or complete assignments;
  - 4. Receive help with schoolwork;
  - 5. Reduce time spent on the computer, reading, and writing;
  - 6. Be granted early dismissal from classes to avoid crowded hallways.

### Annual Review

The policy shall be reviewed annually, and updated as necessary to ensure that it reflects the most current information available on the prevention, risk, and treatment of sports-related concussions and other head injuries.

# SPORTS-RELATED CONCUSSION AND HEAD INJURY FACT SHEET AND PARENT/GUARDIAN ACKNOWLEDGEMENT FORM

**FILE CODE: 5141.8** 

A concussion is a brain injury that can be caused by a blow to the head or body that disrupts normal functioning of the brain. Concussions are a type of Traumatic Brain Injury (TBI), which range from mild to severe and can disrupt the way the brain normally functions. Concussions can cause significant and sustained neuropsychological impairment affecting problem solving, planning, memory, attention, concentration, and behavior.

The Centers for Disease Control and Prevention estimates that 300,000 concussions are sustained during sports related activities nationwide, and more than 62,000 concussions are sustained each year in high school contact sports. Second-impact syndrome occurs when a person sustains a second concussion while still experiencing symptoms of a previous concussion. It can lead to serve impairment and even death of the victim.

Legislation (P.L. 2010, Chapter 94) signed on December 7, 2010, mandated measures to be taken in order to ensure the safety of K-12 student-athletes or cheerleaders involved in interscholastic sports in New Jersey. It is imperative that athletes, coaches, and parent/guardians are educated about the nature and treatment of sports related concussions and other head injuries. The legislation states that:

- All Coaches, Athletic Trainers, School Nurses, and School/Team Physicians shall complete an Interscholastic Head Injury Safety Training Program by the 2011-2012 school year.
- All school districts, charter, and non-public schools that participate in interscholastic sports will
  distribute annually this educational fact to all student-athletes or cheerleaders and obtain a signed
  acknowledgement from each parent/guardian and student-athlete or cheerleader.
- Each school district, charter, and non-public school shall develop a written policy describing the
  prevention and treatment of sports-related concussion and other head injuries sustained by
  interscholastic student-athletes or cheerleaders.
- Any student-athlete or cheerleader who participates in an interscholastic sports program and is suspected of sustaining a concussion will be immediately removed from competition or practice. The student-athlete or cheerleader will not be allowed to return to competition or practice until he/she has written clearance from a physician trained in concussion treatment and has completed his/her district's graduated return-to-play protocol.

#### **Ouick Facts**

- Most concussions do not involve loss of consciousness
- You can sustain a concussion even if you do not hit your head
- A blow elsewhere on the body can transmit an "impulsive" force to the brain and cause a concussion

### Signs of Concussions (Observed by Coach, Athletic Trainer, Parent/Guardian)

- Appears dazed or stunned
- Forgets plays or demonstrates short term memory difficulties (e.g. unsure of game, opponent)
- Exhibits difficulties with balance, coordination, concentration, and attention
- Answers questions slowly or inaccurately
- · Demonstrates behavior or personality changes
- Is unable to recall events prior to or after the hit or fall

## Symptoms of Concussion (Reported by Student-Athlete)

- Headache
- Nausea/vomiting
- Balance problems or dizziness
- Double vision or changes in vision
- · Sensitivity to light/sound
- · Feeling of sluggishness or fogginess
- Difficulty with concentration, short term memory, and/or confusion

### What Should a Student-Athlete do if they think they have a concussion?

- Don't hide it. Tell your Athletic Trainer, Coach, School Nurse, or Parent/Guardian.
- Report it. Don't return to competition or practice with symptoms of a concussion or head injury. The sooner you report it, the sooner you may return-to-play.
- Take time to recover. If you have a concussion your brain needs time to heal. While your brain is healing you are much more likely to sustain a second concussion. Repeat concussions can cause permanent brain injury.

### What can happen if a student-athlete continues to play with a concussion or returns to play to soon?

- Continuing to play with the signs and symptoms of a concussion leaves the student-athlete or cheerleader vulnerable to second impact syndrome.
- Second impact syndrome is when a student-athlete or cheerleader sustains a second concussion
  while still having symptoms from a previous concussion or head injury.
- Second impact syndrome can lead to severe impairment and even death in extreme cases.

# Should there be any temporary academic accommodations made for student-athletes or cheerleaders who have suffered a concussion?

- To recover cognitive rest is just as important as physical rest. Reading, texting, testing-even watching movies can slow down a student-athletes recovery.
- Stay home from school with minimal mental and social stimulation until all symptoms have resolved.
- Students may need to take rest breaks, spend fewer hours at school, be given extra time to
  complete assignments, as well as being offered other instructional strategies and classroom
  accommodations.

# Student-athletes or cheerleaders who have sustained a concussion should complete a graduated return-to-play before they may resume competition or practice, according to the following protocol:

- Step 1: Completion of a full day of normal cognitive activities (school day, studying for tests, watching practice, interacting with peers) without reemergence of any signs or symptoms. If no return of symptoms, next day advance.
- Step 2: Light Aerobic exercise, which includes walking, swimming, and stationary cycling, keeping the intensity below 70% maximum heart rate. No resistance training. The objective of this step is increased heart rate.
- Step 3: Sport-specific exercise including skating, and/or running: no head impact activities. The objective of this step is to add movement.
- Step 4: Non contact training drills (e.g. passing drills). Student-athlete or cheerleader may initiate resistance training.
- Step 5: Following medical clearance (consultation between school health care personnel and studentathlete's or cheerleader's physician), participation in normal training activities. The objective of this step is to restore confidence and assess functional skills by coaching and medical staff.
- Step 6: Return to play involving normal exertion or game activity.

### EMERGENCIES AND DISASTER PREPAREDNESS

The Chief School Administrator shall direct the development of plans, procedures and mechanisms for responding to emergencies and crises in the schools that threaten human life and property. He/she shall consult with law enforcement agencies, health and social services agencies and emergency management planners in developing these plans and shall ensure that they provide for the protection of the health, safety and welfare of the school population as well as supportive services for staff, students and their families.

Plans and procedures shall include these elements:

- A. Cooperation with local government agencies in developing and carrying out a school/community disaster plan that includes procedures for building lockdowns when necessary;
- B. Mechanisms for the orderly evacuation of buildings in case of fire or other emergencies;
- C. Means to provide as much protection as possible for children at school and on their way to and from school;
- D. Training in individual self-protection and survival techniques for students and staff;
- E. Communicating specific instructions to students and staff so that the school emergency plan may be carried out with the greatest possible speed and safety.

The Chief School Administrator shall develop and provide an in-service training program for school staff to enable them to recognize and appropriately respond to crises, consistent with the district's plans, procedures and mechanisms for managing crises. The in-service program shall be reviewed and updated annually.

### School Safety and Security Plan

The board directs the Chief School Administrator and his/her designees to develop and implement comprehensive plans, procedures, and mechanisms that provide for safety and security in the schools. Written plans, procedures, and mechanisms shall, at a minimum, provide for:

- A. The protection of the health, safety, security and welfare of the school population;
- B. The prevention of, intervention in, response to and recovery from emergency and crisis situations;
- C. The establishment and maintenance of a climate of civility; and
- D. Support services for staff, students and their families.

The Chief School Administrator shall consult with law enforcement agencies, health and social services, provider agencies, emergency management planners, and school and other community resources, as appropriate, in the development of the district's plans, procedures, and mechanisms for school safety and security.

The plans, procedures, and mechanisms shall be consistent with the format and content established by the Domestic Secuirty Preparedness Task Force and the Commissioner. The plans, procedures, and mechanisms shall be reviewed annually and updated as appropriate.

The Chief School Administrator shall disseminate a copy of the school safety and security plan to its employees. In addition:

- A. New employees shall receive a copy of the school safety and security plan, as appropriate, within sixty (60) days of the effective date of their employment;
- B. All employees shall be notified in writing, as appropriate, regarding updates and changes to the school safety and security plan;
- C. All employees shall attend an in-service training program designed to allow all district board of education employees to recognize and appropriately respond to safety and security concerns, including emergencies and crisis, in a manner consistent with the district board of education's plans, procedures, and mechanisms for school safety and security.

# Fire Drills and School Security Drills

Fire drills shall be held at least once each month for all students. There shall also be at least one school security drill per month. The Chief School Administrator may order a modification of the fire drills so that they may take the form of indoor drills or of rapid dismissals with outdoor clothing when low temperatures prevail.

A written statement of procedures and instructions for fire drills and school security drills shall be formulated by the Chief School Administrator and disseminated to all staff. All staff shall also receive training on school safety and security that includes instruction on school security drills within sixty (60) days of the commencement of that staff member's employment, whichever date is later.

Instruction in fire prevention shall be given and emphasized in appropriate courses in the curriculum of the school. A "school security drill" shall be defined as an exercise to respond to an emergency situation such as a non-fire evacuation, lockdown, bomb threat or active shooter situation that is similar in duration to a fire drill.

## Required Drills

- A. The school shall be required to conduct a minimum of two drills per year for each of the following drills:
  - 1. Active shooter
  - 2. Evacuation (non-fire)
  - 3. Bomb threats
  - 4. Lockdowns

Students are not required to participate in two of the eight mandated drills.

- B. Within the first ten (10) days of the new school year each school in the district shall be required to conduct one fire drill;
- C. Within the first fifteen (15) days of the new school year each school in the district shall be required to conduct one school security drill.

## Reporting

By June 30<sup>th</sup> of each year the Chief School Administrator shall submit to the Executive County Superintendent an annual "Statement of Assurance" report on the forms provided by the Department of Education.

## Emergency Closings; Delayed Openings

The Chief School Administrator is authorized by the Board to close the schools, open them late or dismiss them early in hazardous weather or in other extraordinary circumstances which might endanger the health or safety of students or school employees.

Each year, parents/guardians, students, and staff members shall be informed in advance of how they shall be notified in event of emergency closings. Parents/guardians shall be required to make alternative arrangements for their children in case no one is home to receive a child after an unscheduled early closing.

### STUDENT ASSESSMENT

The New Jersey statewide assessment program has been designed to measure the extent to which all students at the elementary, middle, and secondary levels have attained the Common Core State Standards (CCSS). The Board of Education will comply with implementing the schedule of the New Jersey State Board of Education statewide assessment program.

### Assessments

The Chief School Administrator shall develop and present to the Board annually for its approval an assessment program that complies with rules of the State Board of Education.

The No Child Left Behind (NCLB) Act of 2001 requires schools with students in grades three through twelve to demonstrate Adequate Yearly Progress (AYP). In order to make AYP, a school must ensure that assessments have been taken by at least ninety-five percent (95%) of enrolled students in each subgroup, i.e., special education, English language learners, low income, race/ethnicity. Federal funding of key education programs is dependent upon districts meeting this requirement.

In compliance with this federal requirement, N.J.S.A. 18A:7C-1 requires the Commissioner of Education (Commissioner), with approval of the State Board of Education, to establish a program of standards for graduation from secondary school, and such a program shall include, "[t]he development of a statewide assessment test in reading, writing, and computational skills to be administered to all secondary school pupils..." In addition, N.J.A.C. 6A:8-4.1(a) and (b) provides, "[t]he Commissioner...may implement assessment of student achievement in the State's public schools in any grade(s) and by such assessments as he or she deems appropriate," and the Commissioner "...shall define the scope and level of student performance on statewide assessments that demonstrate thorough understanding of the knowledge and skills delineated by the CCCS at grade levels three through 12." Subsection (c) further states that district boards of education "shall, according to a schedule prescribed by the Commissioner, administer the applicable statewide assessments," and subsection (d) confirms that "all students at grade levels three through 12, and at any other grade(s) designated by the Commissioner...shall take appropriate statewide assessments as scheduled."

Furthermore, in February, 2014, the State Board passed a resolution confirming that district boards of education are obligated to implement the Core Curriculum Content Standards and to "ensure students meet the expectations and proficiency standards as measured by current and future State and local assessments."

In accordance with the above, State law and regulations require all students to take state assessments. For the 2014-2015 school year, the PARCC assessment will replace the prior statewide assessments the NJASK in grades 3-8 and HSPA in high school; as such, all students shall take the PARCC assessment as scheduled. Since the PARCC assessment is part of the State required educational program, schools are not required to provide an alternative educational program for students who do not participate in the statewide assessment.

### Records

The Board shall maintain an accurate record of each student's performance on statewide assessments in accordance with N.J.A.C. 6A:8-4.2. Information regarding individual student test scores shall be released only to the student, his/her parent(s) or legal guardian(s), or individuals eligible by court order and school personnel and school officials deemed authorized by Federal and State law.

### Dissemination of Information

In accordance with the requirements of N.J.A.C. 6A:8-4.5, the school district is required to report annually to the Board of Education and the public on the progress of all students and student subgroups in meeting the Common Core State Standards as measured by the statewide assessment system by publishing and distributing the Department of Education's Annual School Performance Report in accordance with N.J.S.A. 18A:7E-2 through 6.

### Parent Notification

Parent(s) or legal guardian(s) shall be informed of the district assessment program and of any specific tests that are to be administered to their children.

### PROGRAM EXCEPTIONS

#### Students with Disabilities

Students with disabilities shall participate in all statewide assessments in accordance with the provisions as outlined in N.J.A.C. 6A:14-4.10. Accommodations approved by the New Jersey Department of Education for the administration of the statewide assessment shall be provided to students with disabilities who participate in the general statewide assessment when determined necessary by the Individual Education Plan (IEP) team. Students with disabilities shall participate in an alternate proficiency assessment as provided for in N.J.A.C. 6A:14-4.10(a)2.

## English Language Learners

An English language learner is a person who is in the process of acquiring English and has a first language other than English. ELLs are the same students who are sometimes referred to as limited English Proficient (LEP). All ELLs shall participate in all statewide assessments and may be provided appropriate accommodations as approved by the New Jersey Department of Education.

All ELLs shall satisfy the requirements for high school graduation according to N.J.A.C. 6A:8-5.1, except that any ELL may demonstrate they have attained state minimum levels of proficiency through:

- Passage of the Alternative High School Assessment (AHSA) process in their native language and passage of an English fluency assessment approved by the New Jersey Department of Education; or
- 2. Passage of the AHSA process in English with appropriate accommodations.

Students with disabilities as defined in N.J.A.C. 6A:14-1.3 or eligible under Section 504 of the Rehabilitation Act and who participate in the AHSA process are not required to participate in repeated administrations of the High School Proficiency Assessment (HSPA).

### HOME INSTRUCTION

To provide uninterrupted education for students unable to attend their regular classes because of illness, disability court order or administrative action, the Board of Education shall provide away-from-school instruction subject to the following restrictions:

- A. The period of absence must be expected to be longer than ten (10) consecutive or twenty (20) cumulative school days, except in special circumstances;
- B. A parent/guardian or appropriate adult authority must be within call during the period of instruction; and
- C. In cases of illness or disability, medical certification is required documenting the necessity for the student's absence.

Each case must be approved by Board action; all requirements for receipt of State aid must be fulfilled.

# Temporary or Chronic Health Condition

The board shall provide instructional services to an enrolled student when the student is confined to the home or another out-of-school setting due to a temporary or chronic health condition or a need for treatment that precludes participation in their usual education setting, whether general education or special education.

The parent/guardian shall submit a request for home instruction in writing. The request shall include a written determination from the student's physician documenting the projected need for confinement at the student's resident or other treatment setting. The projected confinement period shall be for more than ten (10) consecutive school days or twenty (20) cumulative school days during the school year.

The principal or his/her designee shall forward the request with the physician's written determination to the school physician, who shall verify the need for home instruction. The school physician may contact the student's physician to secure additional information concerning the students' diagnosis or need for treatment and shall either verify the need for home instruction or shall provide the board with the reasons for denial. The parent/guardian shall be notified concerning the school physician's verification or reasons for denial within five (5) school days after receipt of the written determination by the student's physician.

The district shall provide instructional services within five (5) school days after receipt of the school physician's verification. If the school physician's verification is made prior to the student's confinement instructional services shall be provided during the first week of the student's confinement to the home or out-of-school setting. Instructional services shall be at a minimum meet the following standards:

- A. A written plan for delivery of instruction shall be established to continue the student's academic progress and to maintain a record of delivery of instructional services and student progress;
- B. Teachers providing home instruction shall be certified;
- C. The teacher shall provide one-on-one instruction for the number of days and length of time sufficient to continue the student's academic progress and dependent upon the student's ability to participate;
- D. For a student with disabilities, the home instruction shall be consistent with the student's individualized education plan (IEP) to the extent appropriate and shall meet the Core Curriculum Content Standards (CCCS) including the Common Core State Standards (CCSS) in mathematics and language arts and literacy. When the provision of home instruction will exceed thirty (30) consecutive school days in a school year, the IEP team shall convene a meeting to review and, if appropriate, revise the student's IEP;
- E. For a student without a disability the home instruction shall meet the Core Curriculum Content Standards (CCCS) including the Common Core State Standards (CCSS) and/or the student's IEP as appropriate and the requirements of the board for promotion to the next grade level. When the provision of home instruction will exceed sixty (60) calendar days, the school physician shall refer the student to the child study team for evaluation;
- F. The district shall be responsible for the costs of providing instruction in the home or out-of-school setting either directly, through online services, including any needed equipment, or through contract with another district board of education, educational services commission, jointure commission, or approved clinic or agency. Students who are eligible to receive home instruction as needed at the district's expense are as follows:
  - 1. A student who resides within the area served by the board and is enrolled in a public school program; or
  - 2. A student who is enrolled in a nonpublic school that is located within the area served by the board.

# Reasons Other Than a Temporary or Chronic Health Condition

- A. The district shall provide home or out-of-school instruction for a general education student for reasons other than a temporary or chronic health condition no later than five (5) school days after the student has left the general education program when:
  - The student is mandated by State law and rule for placement in an alternative education program including firearms offenses and/or assault with weapons offenses but placement is not immediately available;

2. The student is placed on short-term or long-term suspension (see Suspension and Expulsion Policy File Code 5114);

3. A court order requires that the student receive instructional services in the home or other out-of-school setting.

The district shall be responsible for the costs of providing instruction in the home or out-of-school setting either directly, or through online services, including any needed equipment, or through contract with another board of education, educational services commission, jointure commission, or approved clinic or agency for resident students.

- B. The home or out-of-school instructional services for reasons other than a temporary or chronic health condition shall meet the minimum standards that are specified in N.J.A.C. 6A:16-10.2(d) including but not limited to:
  - 1. The district shall establish a written plan for delivery of instruction and maintain a record of instructional services and student progress;
  - 2. The teacher providing instruction shall be a certified teacher;
  - 3. The teacher shall provide one-on-one instruction with no fewer than ten (10) hours each week on three (3) separate days of the week and no fewer than ten (10) hours per week of additional guided-learning experiences that may include the use of technology to provide audio and visual connections to the student's classroom;
  - 4. The instruction shall meet the Core Curriculum Content Standards (CCCS) including the Common Core State Standards (CCSS) and board requirements for promotion and graduation;
  - 5. If instruction is delivered in the student's home, a parent or other adult 21 years of age or older who has been designated by the parent shall be present during all periods of home instruction.

Any student receiving home instruction is not considered absent.

### LONG-RANGE FACILITIES PLANNING

The board recognizes that sound planning based on accurate information is essential to the efficient operation of the schools. In order to ensure that future district construction, alterations and/or remodeling is planned on the bases of need, the board, in accordance with state requirements, will prepare the required long-range facilities plan and will update that plan as required thereafter. The long-range plan shall include but not be limited to:

- A. Enrollment projections for the school district for the five years covered by the plan, by grade level, as set forth in the Fall Survey Report for grades kindergarten through twelve and the application for state school aid (ASSA) for the preschool program utilizing enrollment figures as of October 15 of the previous year as the base enrollment figures. The following students shall be separately identified in the enrollment projections:
  - 1. Students attending charter schools;
  - 2. Students attending school choice programs;
  - 3. Students enrolled in the school district but attending private schools for the disabled;
- B. The functional capacity of every school facility in the district, listed separately by facility and grade level, including an inventory of all spaces in each facility;
- C. An inventory of every school facility, other facility and temporary facility in the district;
- D. An inventory of all district-owned land, indicating whether used currently, previously, or never, as a school site, with a map of the district indicating the location of all district-owned land and the location of existing schools in the district;
- E. A listing of the approximate size and nature of any new sites that may be needed for school facilities projects, listing the specific project(s) to be constructed on each site;
- F. An inventory of all building systems within each facility, including structure, enclosure, mechanical, plumbing, interior walls and finishes and electrical systems;
- G. A determination of the life expectancy of all building systems;
- H. A determination of any building system deficiencies in each school facility and the required remediation;
- I. The district's proposed school facilities projects and other capital projects and preliminary scopes of work in the five years ensuing;

- J. The district's proposed programmatic models for school facility types and capacities the school district intends to operate in the five years ensuing;
- K. A comparison of the school district's proposed programmatic models with the facilities efficiency standards and identification of all types of spaces, sizes of spaces and number of spaces inconsistent with those standards;
- L. A comparison of the school district's programmatic models with the existing inventory and how the school district proposes to convert the existing inventory to the programmatic models;
- M. The district's proposed plans for new construction and renovation of other facilities in the five years ensuing, setting forth each proposed new other facility, addition and renovation, including each separate space to be constructed or renovated and all other facilities to be sold, converted to other non-school facility uses or razed;
- N. For each school facility for which the school district is seeking approval of additional space or waiver of a facility efficiency standard to be approved, the school district shall submit documentation supporting the request;
- O. For each school facility to be replaced, a preliminary comparison of the cost of replacement of the school facility verses the cost to rehabilitate the school facility;
- P. Preliminary data to support each proposed new school facility or addition, renovation to an existing school facility and the removal from the school district's inventory of school facilities each school facility to be sold, converted to non-school facility use or razed;
- Q. A preliminary estimate of the cost of every school facilities project set forth in the long-range plan; and
- R. A district board of education resolution approving submission of the long-range plan.

Planning of major rehabilitation and remodeling will be incorporated in to the school district master plan on a scheduled basis.

# Reporting to the Board

In order to apprise the board of the continuing relevance of the capital construction plan, the Chief School Administrator shall annually report to the board:

- A. Number of new residential units approved;
- B. Enrollment by grades during the school year monthly;

C. Student population projections prepared every year, and compare the actual population figures to the previously projected figures to detect early, for the benefit of the board, any changes in population trends.

In planning for the enlargement or modification of its facilities, the board shall consider not only the number of children whose educational needs must be met, but also the physical requirements of the program it deems best suited to meet those needs. Each school building and site shall provide suitable accommodations to carry out the educational program of the school including provision for the disabled, pursuant to law and regulation.

### Substandard Facilities

All existing school facilities will be evaluated annually for their suitability to current district needs. Any facilities found to be substandard according to the administrative code shall be corrected as quickly as possible in compliance with law.
