HISPA Inspires Students to Achieve



NED Motivates Students!



The SkillsUSA Champions at Work, Elizabeth Chapter of the **Thomas** Edison Career & Technical Academy, recently conducted two community service projects.



CONCERNING THE ALARMING INTRUSION OF UNIDENTIFIED SPECIAL INTEREST "SUPER PAC" MONEY INTO LOCAL ELECTIONS

WHEREAS, the electorate of this state, and the City of Elizabeth are best served by full transparency of campaign contributions so that the public can gauge the sources and quantity of financial support received by candidates for the Board of Education; and

WHEREAS, New Jersey's system of public elections has long required the identification of all contributors of more than \$300, through detailed reporting requirements established through the state Election Law Enforcement Commission; and

WHEREAS, since the 2010 United States Supreme Court decision in <u>Citizen's United</u> allowed corporations and labor unions to spend unlimited funds on direct advocacy for and against candidates; and

WHEREAS, these expenditures of funds directly undercuts New Jersey's system of requiring candidate accountability and public transparency, providing spending limits that limit the influence of special interests in local campaigns through organizations known as super Political Action Committees, or "Super PAC's"; and

WHEREAS, without regulation or transparency, political figures can call upon special interests for whom they provide support on legislative initiatives to provide unlimited and unregulated funds to SUPER PACS in order to do their political bidding in a manner that directly undermines pay to play laws and is a fraud on the electorate; and

WHEREAS, the USA Today newspaper recently illustrated this point in an article entitled "Big Money Targets Small Races," by describing such a situation in the 2013 Elizabeth Board of Education election wherein the "Committee for Economic Growth and Social Justice," an innocuously named SUPER PAC based in Washington, DC spent more than \$150,000 to influence the race; and

WHEREAS, the article pointed out that the SUPER PAC in question was heavily financed by the bail bond, legal and online gambling industries, all industries affected by the legislative initiatives of Senator Raymond Lesniak, who openly admitted that the SUPER PAC, which is run by his former campaign consultant, would again be using special interest money this year to influence the Elizabeth Board of Education election; and

WHEREAS, the intrusion of outside interests into the electoral process in Elizabeth and elsewhere subverts the electoral system and undermines democracy by permitting special interests to essentially pay elected officials for their legislative positions without any disclosure requirements, a direct affront to the many laws and regulations in New Jersey and at the Elizabeth Board of Education that attempt to curb political corruption.

NOW, THEREFORE, BE IT RESOLVED, that the Elizabeth Board of Education decries the intrusion of outside influences into local races carefully controlled to avoid pay-to-play and corrupting influences.

BE IT FURTHER RESOLVED, that the Elizabeth Board of Education hereby Petitions its United States Senators, Bob Menendez and Cory Booker, to support and encourage federal legislation, such as the DISCLOSE ACT, and even a Constitutional Amendment, if necessary, which would curb the ability of corporations, industry groups and labor unions from secretly providing unlimited funds to candidates through SUPER PACS without broad and specific disclosure of the source and amount of funds as well as a comprehensive system of criminal and civil enforcement designed to prevent donations to these entities in exchange for legislative favors.

SEEKING AN AUDIT CONCERNING THE USE OF PAID POLICE IN THE ELIZABETH PUBLIC SCHOOLS

WHEREAS, the Elizabeth Public Schools employ off duty Policemen from the Elizabeth Police Department to assist in the schools and properties of the Elizabeth Public Schools; and

WHEREAS, recently, two Elizabeth Policemen have pleaded guilty to crimes involving no show jobs on off duty pay jobs; and

WHEREAS, there are allegations of continued corruption in the Elizabeth Police Department; and

WHEREAS, the expenditure of public funds by the Elizabeth Board of Education for paid police jobs requires that all such expenditures be audited.

NOW, THEREFORE, BE IT RESOLVED, that the Elizabeth Board of Education hereby directs the School Business Administrator/Board Secretary to request an audit from the Elizabeth Police Department as to all paid police jobs in the Elizabeth Public Schools.

BE IT FURTHER RESOLVED, that such audit include names, dates and times of duty and school sites at which such police officers worked.

BE IT FURTHER RESOLVED, that the Elizabeth Board of Education also, hereby petitions the State Comptroller to conduct an independent audit of the paid police jobs in the Elizabeth Public Schools to insure that the Elizabeth Public Schools were not the victim of corruption alleged in newspaper articles and admitted to by the two Elizabeth police officers who have pled guilty to a crime.
