
#### **NJHS Induction**

**WHEREAS**, The Elizabeth School District Board of Education is in receipt of an advisory decision dated March 20, 2017 from the State of New Jersey Office of Administrative Law ("OAL"), which states that four members of the Elizabeth Board of Education had a conflict of interest at the time they voted for the hiring of the interim Assistant Superintendent of Schools for Human Resources; and

**WHEREAS**, the Elizabeth School District Board of Education intends to challenge that advisory decision and will do so before the School Ethics Commission; and

**WHEREAS**, it is necessary for the Elizabeth School District Board of Education to make certain personnel decisions with regard to Assistant Superintendents and other personnel which are mandated by statute and regulation and which cannot be delayed during the pendency of the challenge to the advisory opinion; and

**WHEREAS**, the OAL advisory opinion, unless overturned disqualifies four Board members from voting for the personnel decisions, which must be made by June 30, 2017; and

**WHEREAS**, at least one additional Board member is disqualified from voting for the aforementioned personnel decisions by virtue of familial interests.

**NOW, THEREFORE, BE IT RESOLVED** that the Elizabeth School District Board of Education hereby invokes the Doctrine of Necessity for the reason of approving certain contracts to positions of employment with the Board of Education and that it must do so because of the conflicts of interest for five of nine board members who have conflicts due to their familial and employment interests.
