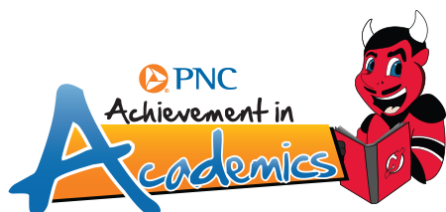
## S.T.E.M Family Night

Students and team members will take part in a variety of activities throughout the month of April to promote acceptance and inclusion for all.

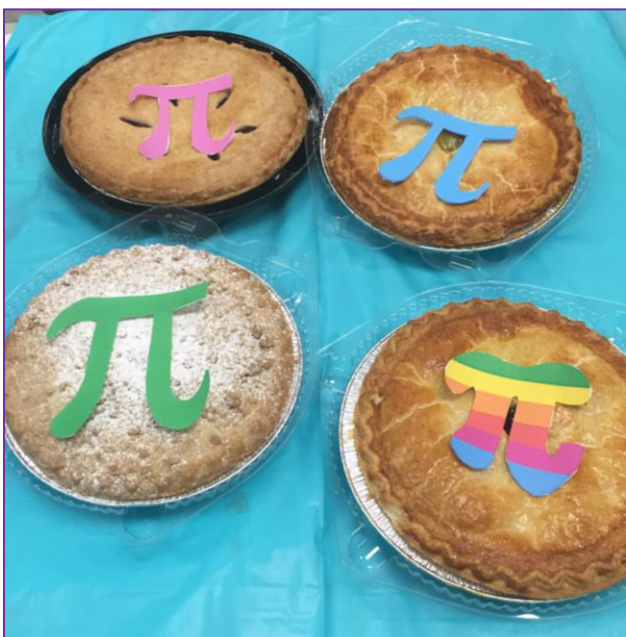


## Mrs. McCarthy's Pi Day Celebration

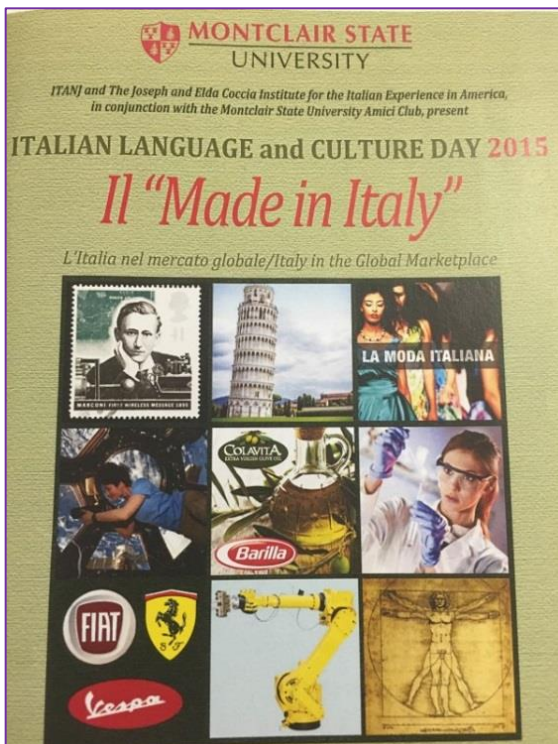


## Junior Seminar

## NJ School of Character

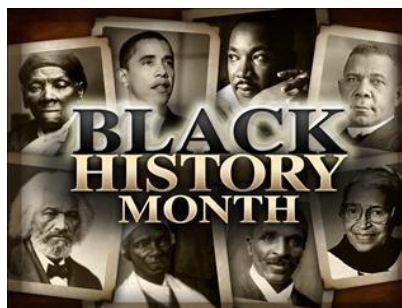

## Raising Awareness

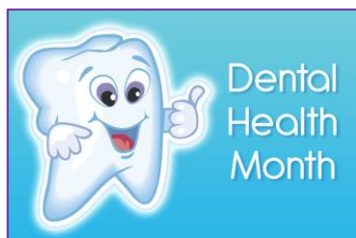

## “Goodnight Ark”

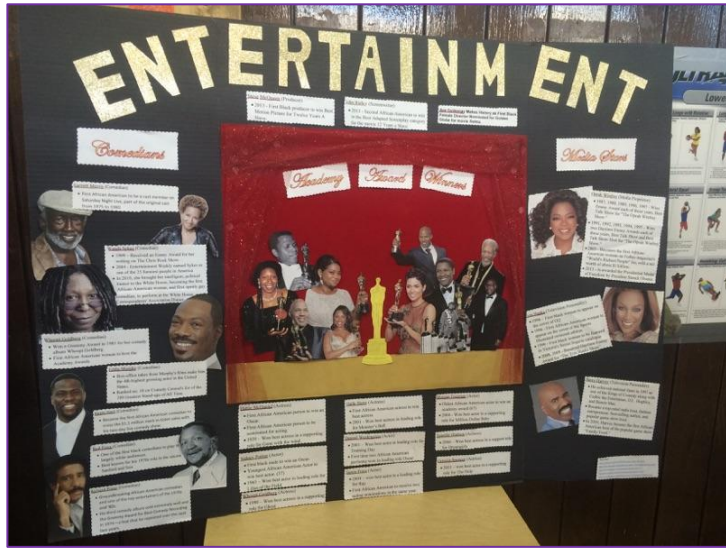
