This calendar provides for 201 K-8 staff days and 200 student days for School #26 and 181 staff days and 180 student days for remaining schools and PreK at School #26. In the event that schools must close for inclement weather, etc., days will be made up commencing with June 14, 2012 with an additional day added to the calendar for each day missed through June 30, 2012 to fulfill the legal requirement of 180 days of school attendance for the regular school year and 200 days for School #26 K-8. If additional days are needed beyond June 30, 2012 days will come from Easter Recess commencing with April 13, 2012 and working backward from the end of that week. Administrative offices will remain open until 4:30 p.m. daily except Fridays during summer hours. On Wed., November 23, 2011, all schools will close at 12:30 p.m. for Thanksgiving Recess. Administrative offices will be open regular hours and all 12 month employees and all secretaries, security personnel, and custodians will follow their regular schedules.
