Thousands of EPS High School Students Attend Teen Health Expo

On May 19, 2015, Elizabeth Public Schools held its eighth annual *Healthy Leap into Summer* health expo in collaboration with organizers Gateway Regional Chamber of Commerce President, James R. Coyle and Trinitas Regional Medical Center Chief Clinical Officer and Vice President of Clinical Operations and Physician Services, Nancy DiLiegro, PhD, FACHE. The health expo, which is the largest teen obesity awareness program in the United States, according to the U.S. Department of Health and Human Services, took place in the Dunn Sports Center at 151 Pearl Street, in Elizabeth.


American Pop/R&B recording artist Miesa entertained students at the rally with her songs *Don't Judge Me* and the recently-released single, *Blame My Ex.*

The success of such learning truly optimized the goal of multicultural awareness and acceptance in an educational environment. When diversity inspires curiosity and conversation, learning flourishes.


Emily Salmanowitz, Senior At Elizabeth High School, Wins The National Merit Scholarship Award

STEAM Roller Coasters



A Plane to Colombia



Second grade bilingual children, from **Nicholas Murray Butler School No. 23** learned about the history of *Cinco de Mayo* celebration.





WHEREAS, the Union County Educational Services Commission has agreed to administer the responsibilities associated with this program for the purpose of greater cost effectiveness through joint purchasing and centralized administration.
