# **Elizabeth Public Schools Honored by the Alliance for a Healthier Generation for Fighting Childhood Obesity**

At the National Healthy Schools Forum in Little Rock, Arkansas, the Alliance for a Healthier Generation, founded by the American Heart Association and the William J. Clinton Foundation awarded Bronze and Silver Awards to 17 Elizabeth Public Schools for transforming their schools into healthier places for students and team members. Admiral William F. Halsey, Jr. Leadership Academy; George Washington School No. 1; Elmora School No. 12; Christopher Columbus School No. 15; Robert Morris School No. 18; Woodrow Wilson School No. 19; and Dr. Orlando Edreira Academy School No. 26 received the Bronze Award.



Schools receiving the Silver Award were Winfield Scott School No. 2; Toussaint L'Ouverture - Marquis de Lafayette School No. 6; Terence C. Reilly School No. 7; Benjamin Franklin School No. 13; Abraham Lincoln School No. 14; Victor Mravlag School No. 21 and William F. Halloran School No. 22 located at Monsignor João S. Antão School No. 31; Charles J. Hudson School No. 25; Juan Pablo Duarte-José Julián Martí School No. 28; Dr. Albert Einstein Academy School No. 29; and Ronald Reagan Academy School No. 30.

Former President Bill Clinton cited the cities of Elizabeth, NJ; Miami, FL; Los Angeles, CA; and Prince George's County, MD as having the highest number of schools awarded. Clinton said, "It takes this kind of collaboration between schools, their students, and national partners to reverse the childhood obesity epidemic in the United States."

To earn these awards, each school revamped its food service and physical activity programs to meet or exceed stringent standards set by the Alliance for a Healthier Generation's Healthy Schools Program, which provides expert advice and free resources to more than 12,000 schools nationwide to help them reverse the national trend in childhood obesity. Schools are eligible for Bronze, Silver, Gold or Platinum National Recognition Awards based on their level of achievement. As Bronze and Silver National Recognition Award winners, these schools join 274 other schools that are receiving this honor for their healthy achievements.

"We commend the dedication of our healthy schools for their efforts to offer students and staff nutritious meals and a variety of physical activity opportunities," said Ginny Ehrlich, chief executive officer of the Alliance for a Healthier Generation. "Their success proves that despite academic pressures and budget constraints, schools can develop environments that foster healthy lifestyles to benefit young people now and into the future."

Superintendent of Schools Pablo Muñoz praised the schools' achievement. "I am proud that our schools have become the healthiest in America and I applaud our team members for their commitment to our students' personal well-being. ## **Watchung Reservation**

Select students of the eighth grade class from **George Washington School No. 1** participated in a field trip to the Trailside Center at Watchung Reservation. Dividing into two groups, students were led by their guides on two separate tours: *New Jersey's Wildlife* and *The Lenape of New Jersey*.

Students spent the morning exploring the woods, tracking the deer and observing numerous squirrels and chipmunks along with robins, cardinals, and a very plump

rabbit. After dining 'al fresco' in the company of a red-tailed hawk, they visited the museum to examine Lenape Indian artifacts before returning to the woods to study plants used by the Lenape for healing and nourishment. Students learned about New Jersey's past and what it has to offer now.

### **American Jewish History**

Ms. Demoleas and Mr. King's sixth grade students, from **Benjamin Franklin School No. 13**, visited the National Museum of American Jewish History in Philadelphia, PA. In preparation for the tour, students researched famous American Jews, which included Barbara Streisand, Sandy Koufax, and Estee Lauder.

The tour guide took the group through 350

years of American Jewish History, including their immigration process into the United States. This experience helped students recognize the need for tolerance and acceptance of people from different cultures and races.



## **Kean University**

Five senior English classes from **Alexander Hamilton Preparatory Academy** visited Kean University library for five Fridays. The visits were designed to accomplish two objectives: to help the students develop information literacy competencies and prepare for college-level research assignments.

The visits were coordinated by Hamilton Academy librarian Janette González, along with high school principal George Mikros and teachers Susan Tamburro and Ward Brenckman. Each of the students received an information package, lunch box and USB flash drive. Students were also invited to return to the Library for further research whenever

needed. Students were welcomed by University Librarian Luis Rodriguez. Charlotte Diakite and Cynthia Sanchez from Undergraduate Admissions introduced the students to Kean University, provided a video tour, and answered questions about the application and admissions process.

# **Healthy Alliance Team**

The Healthy Alliance Team at **George Washington School No. 1** meet on the first Thursday of every month to discuss how to improve the health for both team members and students during lunch and in the afterschool programs. The team walks during lunch, eats healthier snacks and takes this time to discuss various ways in which they can achieve the silver medal award from the Healthy Alliance for next year.

### Mattano Park Project

**Elizabeth High School** members of Mrs. Chaika's Skills USA Club and Mr. Perretti's Science Club met at Mattano Park on April 25 to conduct a bird count. Elizabeth High School students became familiar with nature in the area and the creating and sharing of biological data.

Students were impressed by the diversity of the migratory, wading, and shore birds at the Park. Utilizing the *Celebrating Urban Birds' Survey*, different groups observed over 26 species of birds. This data will be uploaded to the Nest Watch



Database, a nesting database created by Cornell University. In addition, six bird nest boxes were donated and installed in the park and the students received training on how to monitor and maintain them. Groups of students volunteered to take ownership of the boxes throughout the year.

Members from the Trailside Museum brought along some of their naturalists to help with the program during the day. The Rotary Club of Elizabeth donated binoculars and bird field guides to the Science Club for this and future events. Other community participants were: AmeriCorps; Union County Board of Chosen Freeholders; Directors of Dept. of Parks and Community Revival; Groundwork Elizabeth; NJ Tree Foundation; and the American Corp NJ Water ambassador. After lunch, students split into groups to conduct litter clean-up. About thirty silky dogwoods trees and willow oaks trees were planted.

All of the participants walked away with a new appreciation of our local environment and a sense of accomplishment. Some students expressed an interest in becoming active participants in environmental issues that affect our region.

### NAFOPOLY

Students and team members in the National Academy Foundation's Academy of Finance (NAF-AOF) at the **William F. Halsey, Jr. Leadership Academy** worked together to create a gigantic, wall-mounted NAFOPOLY game with design and layout features similar to those found in the classic *Monopoly* board game.

The NAFOPOLY game, which is 24 feet long and 5<sup>1</sup>/<sub>2</sub> feet high, covers one entire wall of the NAF-AOF classroom at Halsey. Instead of featuring famous streets and locations in Atlantic City as the traditional Monopoly game does, the



NAFOPOLY squares focus on the financial concepts, corporation case studies, and business practices the NAF-AOF students study as part of their coursework in business ethics, entrepreneurship, economics, and business law. Key words that are an integral part of the total NAF curriculum, such as integrity, diversity, morality, and honesty, are also highlighted. The NAFOPOLY concept was developed by Ms. Dana Rivas, a NAF-AOF teacher and the character drawings were done by Juan Asalde.


### **Music Under the Stars**

**BE IT FURTHER RESOLVED,** that Justice Stein and Pashman Stein, P.C., are being retained to conduct an independent review and to issue an independent and objective report, as well as to make recommendations for the adoption of policies and procedures that will assure all Board of Education employees that any participation on their part in political contributions or activities is completely voluntary and any participation or non-participation is completely unrelated to the fulfillment of their responsibilities as employees of the Board of Education; and

**BE IT FURTHER RESOLVED,** that retired New Jersey Supreme Court Justice Gary S. Stein and Pashman Stein, P.C., report the findings of its internal review to the Board;

# RESOLUTION

**WHEREAS,** Section 504 of the Rehabilitation Act of 1973 is a national law that prohibits discrimination on the basis of disability in all programs and activities receiving federal financial assistance, and

**WHEREAS,** the Section 504 l aw requires that a 504 O fficer be assigned to field complaints from parents once a 504 Plan has been developed.

**NOW, THEREFORE, BE IT RESOLVED,** that the Board of Education hereby approves that Anne O'Dea, Supervisor for Special Services be assigned as the 504 Officer for Elizabeth Public Schools for the 2011-2012 school year.
