BOARD OF EDUCATION (Official)

March 17, 2011 Elizabeth, New Jersey

The regular meeting of the Board of Education was called on March 17, 2011 at 7:00 p.m., in the Multi Purpose Room, Donald Stewart Center for Early Childhood Education, 544 Pennsylvania Avenue, Elizabeth, New Jersey.

Board President Carlos Trujillo presented the following statement at 7:15 p.m.

"Ladies and Gentlemen, good evening. This is a regularly scheduled meeting of the Board of Education. Pursuant to New Jersey Statutes and the rules adopted by the Board of Education, notice of this meeting was sent to The Star Ledger and Cablevision of Elizabeth on Friday, March 11, 2011. In addition, this notice is posted on the Bulletin Board in the lobby of 500 North Broad Street, and pursuant to this act, a copy has been filed with the City Clerk of Elizabeth."

"I wish to extend a warm welcome to everyone present and to our television viewers to this March 17, 2011 meeting of the Board of Education. We are here to govern, provide management oversight, and make policy for the district. The Superintendent manages the district. This is a meeting of the Board in public, not a meeting of the public."

"This meeting is being recorded and will become part of the Elizabeth Board of Education permanent record. In order that the recording will adequately reflect the proceedings, please refrain from talking while others are speaking. I also ask that you silence the sound on your electronic devices. Since it is legally mandated that these proceedings be accurately recorded, I may have to ask for order periodically should noise begin to interfere with our recording capabilities. I am pleased that you have taken time this evening to join us. Thank you for your interest in the Elizabeth Public Schools."

"There will be a public portion for citizens to address the Board. Participants for the public portion must sign in one hour prior to the advertised start of the meeting so that they may have the opportunity to speak. The sign-in sheet states the name, address, telephone number and reason that the person wants to comment, whether it is an agenda item or a general education comment."

The Pledge of Ethics was led by Isaac Iheke, Student Government President of Elizabeth High School.

Mr. Trujillo introduced a video presentation of the Core Beliefs and Commitments.

Mr. Trujillo thanked the students in the Terence C. Reilly Jazz Ensemble for their wonderful performance of the *St. Louis Blues* by William C. Handy, *Salsa Caliente* by Bobby Shew, and *Inside Out* which were heard prior to the beginning of the Board meeting.

Mr. Trujillo introduced students from the Dance Ensemble at Terence C. Reilly School No. 7 who performed *It's Not Over* by Juda Camp. Mr. Trujillo thanked the students for the wonderful performance.

Mr. Trujillo introduced students from the Show Choir at Terence C. Reilly School No. 7 who performed *Hairspray* by Marc Shaiman. Mr. Trujillo thanked the students for the wonderful performance.

Mr. Trujillo recognized students from the Elizabeth High School Forensic Team for their excellent performance at the New Jersey State Forensic Tournament who won 5th place in Speech Sweepstakes Trophy and 6th place in the Overall Sweepstakes Trophy. Mr. Trujillo congratulated the three students, Edess Damis, Danny Luca, and Jacques Point Du Jur, who won State Champion Honors and are also being awarded a scholarship by the New Jersey Forensic League and have been invited to attend the Governor's Awards in Arts Education. Mr. Trujillo recognized students Edess Damis and Jacques Point Du Jur, Duo State Champions; Danny Luca, Improvisational Acting State Champion; Edess Damis, 2nd Place in Humorous Interpretation; Isaac Jimenez, 3rd Place in Improvisational Acting; Kyle Valente and Tome Correia, 5th Place in Public Forum Debate; Oscar Abella and Daysi Martinez, 7th Place in Public Forum Debate; Isaac Jiminez, Christian Mendoza, and Andre Jordao, Humorous Interpretation Semifinalists; Kristina Bosnic and Danny Luca, Duo Interpretation and Coach Renee Dembski, who was ill and could not be present for the meeting, and Assistant Coach Kevin Mills. Mr. Trujillo and Board members congratulated the students and presented each with a plaque of commemoration.

Kevin Mills, Assistant Coach for the Elizabeth High School Forensic Team, congratulated Head Coach Renee Dembski and the students for their excellent performance at the State Forensic Tournament and for their hard work during the year and thanked the Board for the honor.

Mr. Trujillo introduced community leader, former City Councilman of the City of Elizabeth, and former Elizabeth Board of Education member Tony Monteiro and requested that he join the Board members in the presentation to Fernando Santos. Mr. Trujillo commented that we are honoring Fernando Santos, former Editor of Luso Americano Newspaper for his many years of service to the community. Mr. Trujillo stated that for thirty-six years Mr. Santos was a dedicated journalist who spent his life contributing to the advancement of media sources that spoke directly to the culture of fellow Portuguese-Americans, that Mr. Santos was awarded several prizes in journalism including the Talent in Media Award by the Portuguese government in 2008 for promoting intercultural exchange of ideas and that since retiring he has devoted his free time to writing the history of the Portuguese people in New Jersey. Mr. Trujillo presented Mr. Fernando Santos with a plaque of commemoration for his excellent contributions in the field

of journalism to the Portuguese-American community and his lifelong dedication to the advancement of education and cultural exchange.

Mr. Santos thanked the Board for the award and commented that it is a special honor because it comes from a body that is very well known for their seriousness for teaching and promoting learning and from a Board, in such a diverse City as Elizabeth, that promotes the meaning and understanding of cultures. Mr. Santos commented that he has dedicated his life to promoting an understanding of different cultures. Mr. Santos stated that he is honored to receive this award and thanked the Board for the honor.

Mr. Monteiro thanked Fernando Santos for his work as editor-in-chief of the largest Portuguese paper circulated throughout the United States of America. Mr. Monteiro stated that his journalistic style, integrity and wit will certainly be missed throughout all of New Jersey and the country. Mr. Monteiro stated that we appreciate your years of friendship and all that you have done for the City of Elizabeth through all the good articles that you wrote. Mr. Monteiro thanked the Board of Education for honoring and recognizing such a valuable individual, Fernando Santos, who besides being a great journalist is an all around great human being.

Mr. Trujillo offered his Irish-American friends an Irish blessing, "May the sun always shine on your face, may the wind always blow on your back, may the devil know you're dead half an hour after you arrive in heaven, may the Good Lord keep you in the palm of his hand and never make a fist. Amen." Mr. Trujillo wished everyone a Happy St. Patrick's Day.
