BOARD OF EDUCATION (Official)

July 18, 2019 Elizabeth, New Jersey

The regular business meeting of the Board of Education was called to order immediately following the agenda meeting on July 18, 2019 in the MultiPurpose Room, Donald Stewart Center for Early Childhood Education, 544 Pennsylvania Avenue, Elizabeth, New Jersey.

Board President Stephanie Pestana presented the following statement at 10:33 p.m. since the agenda meeting was held prior to the business meeting.

"Ladies and Gentlemen, good evening. This is a regular business meeting of the Board of Education. Pursuant to New Jersey Statutes and the rules adopted by the Board of Education, notice of this meeting was sent to The Star Ledger and Cablevision of Elizabeth on July 11, 2019. In addition, this notice is posted on the Bulletin Board in the lobby of 500 North Broad Street, and pursuant to this act, a copy has been filed with the City Clerk of Elizabeth, New Jersey.

We want to welcome everyone present and our television viewers to this meeting of the Board of Education. We are here to govern, provide management oversight, and make policy for the district. The Superintendent manages the district. This is a meeting of the Board in public, not a meeting of the public.

This meeting is being recorded and will become part of the Elizabeth Board of Education permanent record. In order that the recording will adequately reflect the proceedings, please refrain from talking while others are speaking. We also ask that you silence the sound on your electronic devices. Since it is legally mandated that these proceedings be accurately recorded, we may have to ask for order periodically should noise begin to interfere with our recording capabilities. We are pleased that you have taken time to join us here for our Board of Education meeting. Thank you for your interest in the Elizabeth Public Schools."

"There will be a public portion for citizens to address the Board. Participants for the public portion may sign in up to the start of the public speaking so that they may have the opportunity to speak. The sign-in sheet states the name, address, telephone number and reason that the person wants to comment, whether it is an agenda item or a general education comment."

Superintendent of Schools Olga Hugelmeyer, School Business Administrator/Board Secretary Harold E. Kennedy, Jr., Co-General Counsel Jonathan Williams, Esq. of DeCotiis, Fitzpatrick & Cole, LLP and members of the public were in attendance.

Board President Stephanie Pestana presented the following public participation statement.

"At this time, the microphones are open for public comment to those who have signed in. I shall call individuals to the microphones based on the order of the sign-in. Each statement made by a participant shall be limited to three minutes in duration. The total time of public comment shall be limited to sixty minutes. No individual is able to yield their time to another individual. All statements shall be directed to the presiding officer; no participant may address or question Board members individually. The following rules for public participants shall apply: time limits will be strictly enforced, no personal attacks on individuals, no vulgar or indecent language, a person may address the Board no more than once during a single meeting, speakers should refrain from naming individuals, and comments or questions posed during public participation will not be debated. As a reminder, this is a meeting of the Board in public, not a meeting of the public."

Since there were no public participants signed in to address the Board, Mrs. Pestana closed this portion of the meeting.

Mrs. Pestana stated the Elizabeth Board of Education and Elizabeth Schools Administration believe that its schools and facilities should be centers of community activities and enjoyment. Mrs. Pestana stated that our public schools play a vital role in the quality of life in our community and we are proud and pleased to be seen as an integral part of the City we serve.

Mrs. Pestana stated that the Elizabeth Board of Education is reaffirming and clarifying long-standing policies, rules, regulations and procedures related to the process for approval for use of facilities and the long-standing fees associated with this use. Mrs. Pestana stated that these fees are not new and they are simply being detailed. Mrs. Pestana stated that the district receives and approves hundreds of requests from community groups each year for use of its facilities. Mrs. Pestana stated that the district seeks only to recoup its costs for custodial and security personnel when the facilities are not being used for school functions. Mrs. Pestana stated that the District has always waived fees for community groups, if the facilities are simultaneously being used for school activities, since there is then no increased cost for security or personnel. Mrs. Pestana stated that policy remains.

Mrs. Pestana stated that the Board of Education is proud of its record of fiscal responsibility. Mrs. Pestana stated that for three consecutive years, the district has held the line on property taxes while at the same time increasing the number of schools, teachers, and programs for our students. Mrs. Pestana stated that the Board of Education is simply reaffirming its commitment to a balance of its fiduciary responsibility to the taxpayers and the benefits to the community of social activities in district facilities.

Mrs. Hugelmeyer highlighted some of the articles in the Inside EPS Summer Edition. Mrs. Hugelmeyer stated that a record number of 1,459 graduating seniors of J. Christian Bollwage Finance Academy, John E. Dwyer Technology Academy, Thomas A. Edison Career and Technical Academy, Elizabeth High School Frank J. Cicarell Academy, Admiral William F. Halsey, Jr. Health and Public Safety Academy, Alexander Hamilton Preparatory Academy, and Thomas Jefferson Arts Academy received their diplomas in commencement ceremonies on June 24, 2019 at Williams Field.

Mrs. Hugelmeyer stated that the next article honors senior Justin Dolalas from Elizabeth High School Frank J. Cicarell Academy who earned the National Speech and Debate Association's prestigious Academic All-American Award. Mrs. Hugelmeyer stated that the Academic All-American Award recognizes high school students who have earned the degree of Superior Distinction (750 points); completed at least five semesters of high school; demonstrated outstanding character and leadership; and earned a GPA of 3.7 on a 4.0 scale. Mrs. Hugelmeyer stated that fewer than 1,000 students from more than 141,000 student members of the National Speech and Debate Association earn the Academic All American Award every year, placing Justin Dolalas among the top 1% of all student speech and debate members across the country.

Mrs. Hugelmeyer stated that the next article honors senior Hugo Rebolledo from Elizabeth High School Frank J. Cicarell Academy who received a full four-year scholarship for the Naval Reserve Officers Training Corps. Mrs. Hugelmeyer stated that the NROTC scholarships cover a student's college expenses for their academics, summer training sessions, and a commitment to a number of years of active military duty. Mrs. Hugelmeyer stated that Hugo Rebolledo joins Christopher Derival, Class of 2018 from Admiral William F. Halsey Health and Public Safety Academy who received a full four-year NROTC scholarship.

Mrs. Hugelmeyer stated that the next article is that the Elizabeth Police Department visited the Elizabeth Public Schools special education and related services extended school year program at Elizabeth High School Frank J. Cicarell Academy to help teach students life skills. Mrs. Hugelmeyer stated that the ESY program provides instruction and therapeutic services to students who are eligible for special education and related services beyond the regular school year as indicated in the students' individual education plan.

Mrs. Hugelmeyer stated that the next article is that Toussaint L'Ouverture-Marquis de Lafayette School No. 6, Madison Monroe School No. 16, and Robert Morris School No. 18 are collaborating together to host a *Schools In* educational workshop for their students and families in grades K-8 to promote student learning during the summer months. Mrs. Hugelmeyer stated that the research shows a considerable amount of information learned during the school year can be lost during the summer months while students are out of school. Mrs. Hugelmeyer stated that the workshop will provide information and resources for parents and students to help make gains during the summer months. Mrs. Hugelmeyer stated that the informational workshop will focus on four specific areas including English language arts and math tips and resources to help reinforce learning at home, district approved web links for families to view and access at home, ready made reference of skills in both language arts and math in grades K-8 for parents to help students succeed in their upcoming grade level, and support from a guidance counselor and social worker on topics such as goal setting, homework skills, and other areas to focus on for a successful school year.

Mrs. Hugelmeyer stated that the last highlighted article is the City of Elizabeth Department of Recreation, in conjunction with members of the coaching staff from the Elizabeth varsity boys' basketball team, provided community children the opportunity to participate in a basketball clinic. Mrs. Hugelmeyer stated that the clinic instructed participants on various offensive and defensive basketball fundamentals such as dribbling, passing, shooting, rebounding, and positioning during team and individual activities.

Mrs. Pestana thanked Mrs. Hugelmeyer for the report. Mrs. Pestana wished everyone a happy summer.

On a motion by Mrs. Barbosa, seconded by Mrs. Hernandez, the meeting was adjourned at 10:46 p.m.
