#### **Student Responsibilities**

All students are responsible for maintaining a satisfactory level of academic performance. This is demonstrated by completing all the required assignments, benchmarks, class work, homework, and projects/papers and achieving a grade of *Satisfactory* (70) in elementary grades or a 70 at the middle school level. Dr. Orlando Edreira Academy adheres to all requirements for promotion and retention adopted by the Elizabeth Board of Education. As such, any student whose final grade in language arts literacy or mathematics falls below 70 or *NI* will be referred to summer school classes and **may face retention** in his/her current grade. Students' grades are accessible via the PowerSchool online system at Student and Parent Sign In (powerschool.com).

# **Board Policies**

#### **ATTENDANCE**

According to State Law, it is the obligation of every parent to ensure that every child under his/her care and supervision receives an adequate education and training and, if of compulsory age, attends school. A student must be in attendance at least 171 of the 180 day school year (95%), In order to be considered to have successfully completed the instructional program requirements of the grade to which he/she is assigned, no more than a total of (9) nine absences is allowed. Anything beyond that the student might need to attend summer school or face possible retention.

Dr. Orlando Edreira Academy has an additional attendance policy. While the one above reflects the need to be in school in order to receive the required instruction needed to be academically successful, students who are chronically absent or late face possible removal from this school. Students are allowed fourteen (14) tardies/lates/early dismissals or fourteen (14) absences for the school year. Anything above that, the student will be subject to removal from Dr. Orlando Edreira Academy and will be returned to his or her neighborhood school. You are able to find out how many days your child is late by calling the school or looking on Power School. Additionally, every progress report and report card shows the number of tardies or absences. A tardy is when a child arrives at school after 7:30 or leaves before 3:00 and includes what is typically referred to as a tardy, late, or early dismissal. Excused tardies and absences will not count toward our attendance policy, but will be documented in Power School. Please review the board policy to determine which tardies or absences are considered excused. The school opens its doors and allows students in at 7:05 which is 25 minutes before we mark students late.

#### CARE OF SCHOOL PROPERTY

<u>Vandalism</u> - Rules against vandalism are strictly enforced. Vandalism includes any damage to school property, no matter how seemingly insignificant. Parents will be expected to pay for damage done by their children.

<u>Lockers</u> - Lockers are the property of the Elizabeth Board of Education. The school has the right to inspect lockers as they are school property. Unannounced locker inspections may be randomly conducted throughout the school year.

<u>Laptops</u>- All K-8 students are eligible to receive Windows laptops to support learning. Middle school students may be allowed to take their computers home daily to charge. It is at the discretion of the school and teacher whether or not to allow computers home, and under what conditions. All students with laptops must adhere to Board File Code: 6142.10. This code is on our website in its entirety. Parents are responsible for lost or damaged computers.

#### CELL PHONES AND ELETRONIC DEVICES

Cell phones, IPod, beepers, headphones, radios, and other electronic devices are not to be used in school. They will be confiscated if seen and a parent must come to school to pick up the confiscated items.

#### DISCIPLINE POLICY

Respect and responsibility is the cornerstone of an Elizabeth Public School education. The ideal discipline is self-discipline acquired gradually as a child grows. Our expectations for student behavior include respect for all members of the school community. We expect our students to be kind, courteous, cooperative, and hard-working. In accordance with the Elizabeth Board of Education Policy Code 5131, the board prohibits acts of harassment, intimidation, or bullying/cyber-bullying against any student.

Bullying is defined as any gesture, written, verbal or physical act that is perceived as being motivated either by any actual or perceived characteristic, such as including but not limited to: race, color, religion, creed, national origin, gender, sexual orientation, gender identity and expression, or a mental, physical or sensory handicap. Bullying will not be tolerated and will be fully investigated with appropriate action taken to ensure that it does not happen again.

Student misbehavior which can be treated within the classroom environment by the implementation of simple modification of behavior patterns shall be the responsibility of the classroom teacher. Principals shall ensure that discipline is administered uniformly within each school.

The following are reasons for suspensions:

- Involving oneself in a physical fight.
- Smoking, drinking alcohol, vaping, or use of any controlled or illegal substance on school property or at any school sponsored event.
- Making threats/cyber-threats to other students or engaging in other unacceptable behavior.
- Demonstrating disrespect towards a faculty member, including threats, or use of inappropriate language.
- Defiance of authority and disruption of the educational process.
- Stealing or extortion.
- Harassment, intimidation or bullying/cyber-bullying.
- Leaving school without permission.
- Possession of any kind of weapon.
- Arson or false fire alarm.
- Any type of inappropriate sexual activity.
- Violation of the "Internet Use Policy."

#### **DISMISSAL**

To ensure the safe and orderly dismissal of all students from the school we ask that you adhere to the following important matters:

- An early dismissal is when a child is signed out of the building before 2:45
- From 2:45-3:00 no student will be called down to the office for dismissal, except for emergencies. Parents will have to wait until the school dismisses all students at 3:00.
- No parents will be allowed to enter the building between 2:45 and 3:00.

- If you require a change in how your child is dismissed, for a given day or permanently, it **must be submitted in writing**. As minors, students are not permitted to relay instructions to the office that change the status of their dismissal (e.g. taking the bus, walker, parent pick-up).
- We understand that emergencies do occur. If you are going to be late at dismissal please call the main office at (908) 436-5970 to inform us. If we do not hear from you and you are more than 30 minutes late Board policy dictates that DCP&P/DYFS and the Elizabeth Police are both called.

#### DRESS CODE/UNIFORMS

Clothing should not detract from the educational process, either through creating an unsafe or dangerous environment, or by calling undue attention away from the learning environment. Unacceptable clothing includes:

- Hats, bandanas, scarves, and other inappropriate head gear including hooded garments.
- Wearing any article containing offensive or obscene symbols of language that can be disruptive or a distraction to the educational process at school.
- Half-shirts, belly shirts and halter-tops.
- Transparent garments.
- Any other garment that calls attention away from the educational climate.

Students in schools with uniforms must wear the complete uniform at all times. Dr. Orlando Edreira Academy is a uniform school and adheres to the school uniform policy requiring students to be in a full approved school uniform every day. Students who are not in a complete uniform for six or more days over the course of the year will be considered to be openly defying a requirement of the school and will be in violation of the uniform policy. Such student will be subject to additional discipline action relating to "Defiance of authority and disruption of the educational process." Students in violation of the uniform policy will be transferred back to their neighborhood school after the sixth instance of not being in complete uniform.

# **EARLY DISMISSAL**

A student requesting an early dismissal from school must bring a note from a parent or guardian to the classroom teacher or main office. The note must contain a phone number at which the parent or guardian can be reached. The main office will then call to verify the note and/or clarify instructions. The parent or guardian must pick up the student at the approved time from the main office and sign the student out of school.

#### **EMERGENCY DRILLS**

Crisis Drills include Lockdown, Bomb Threat, Active Shooter, and Evacuation non-fire. All procedures for responding to these drills are posted in every classroom. During Crisis Drills, the principal or person in charge will give directions over the PA system. All students, staff, and visitors must adhere to the instructions. Some of these drills require the schools to be "locked-down." During a lock-down, no one may enter or leave the building and phones will not be answered. At least one crisis drill and one fire drill will be conducted each month. Drills will occur at random times and are unannounced to faculty and staff. Drills are planned over a month

in advance and cannot be adjusted for convenience or to occur only during fair weather. Parents and students will be informed after a crisis drills takes place, but not fire drills as per state law.

# EMERGENCY SCHOOL CLOSINGS AND DELAYED OPENINGS

Emergency school closings and delayed openings due to inclement weather or any other emergency situation will be announced on the following radio/television stations: WOR (710 AM), WINS (1010 AM), WCTC (1450 AM), WMGQ (98.3 FM), NJ (101.5FM) as well as on WABC-TV, News 12 New Jersey, and FOX WNYW. The district also utilizes a Honeywell telephone messaging system. Therefore, it is critical that the main office has your most recent home telephone number at all times.

#### **FINES**

The school furnishes books and materials such as calculators, musical instruments, laptops, etc. to all students. It is expected that the students will properly safeguard and take care of these items. Parents are responsible for the responsible for the replacement and payment of any lost or damaged books or materials. Students will be fined appropriately for each lost workbook, textbook, library book, musical instrument, or tablet.

# FOOD AND NUTRITION SERVICES

School breakfast and lunch are served daily in our schools. It is imperative that you accurately complete a breakfast/lunch application so that your child's payment status can be determined. #### **HEALTH SERVICES**

The school nurse is available during school hours for the administering of authorized prescribed student medication and medical emergencies. Parents/guardians need to provide the school main office and the nurse a current contact telephone number for student medical emergencies. All prescribed medication must be in clearly labeled bottles and accompany a doctor's note. All medicines and paperwork for them must be renewed each year. # INTERNATIONAL BACCALAUREATE

Dr. Orlando Edreira Academy is committed to the IB program in all grades and for all students. To that end what classes, how they are taught, and the expected learning outcomes are heavily influenced by the IBO's philosophy and pedagogy. IB is a prestigious educational program that will help your child be a successful learner and citizen in a 21st century globally connected world. We expect all students to adhere to the program's requirements. To achieve that goal, we ask that all parents support their children to become internationally minded students by also becoming more aware of the IB program and reinforcing its concepts, ideas and ideals at home. Requirements specific to the MYP include, but are not limited to Language Policy, Academic Honesty Policy, Assessment Policy, and Inclusion/Special Educational Needs Policy. All of these

#### INTERNET POLICY/CYBER BULLYING

All students and parents/guardians are required to read, sign, and return the district's "Internet Use Policy" for computer use. The following conduct is not acceptable:

- Sending or displaying offensive messages or pictures.
- Using obscene language.
- Harassing, insulting, or attacking others.
- Damaging computers, computer systems, or computer networks.
- Violating copyright laws.
- Using an unauthorized password.
- Giving others access to your password.
- Trespassing in folders, work, or files.
- Intentionally wasting limited resources.
- Employing the network for commercial purposes.
- Accessing chat rooms unrelated to school study or assignments.

# **PARKING LOT**

During arrival (7:00-7:45) and dismissal (2:45-3:15) no parent or guardian will be allowed to drop off or pick up students in front of the school. You are welcome to park in any non-reserved space that is available in our parking lot. At no time should you park in any area not designated as a parking space or along the school in the fire zone or an area designated for buses.

# PROMOTION/RENTION POLICY

The Elizabeth School District recognizes that students advance through the grades by demonstrating proficiency of required key skills at each grade level. To help all students attain these skills, their promotion/retention is based on the following criteria in grades K-8:

- Students who demonstrate proficiency at the end of a given grade, as measured by the following criteria, will be promoted to the next grade:
  - Proficiency of required skills as measured by the Elizabeth Public Schools Summative Assessment Portfolio
  - o Final report card grades of E, G, S in Elementary grades and 70 or above in Middle grades, in Reading/English/Language Arts Literacy or Mathematics
  - o Attendance- fewer than 9 absences.
- Students who do not demonstrate proficiency based on the above criteria at the end of a given grade level will be required to participate in the district summer school program.

- Students who do not meet the proficiency requirements and attendance criteria by the end of the summer school program will be retained.
- In grades K-2, the appropriate district standardized assessment in Reading, Language, and Mathematics, and in grades 3-8, the appropriate New Jersey State standardized assessment in both Language Arts Literacy and Mathematics will be used in addition to the above criteria as factors in the determination of the student's eligibility for promotion.

Parents/guardians will be notified in the event that his/her child may be retained. The final decision in all cases will rest with school authorities.

#### REPORT CARDS

Report cards are posted four times during the school year. Each marking period consists of approximately 45 days. To access them use this link: Student and Parent Sign In (powerschool.com). Students in the middle school (grades 6-8) will additionally receive an IB report card along with the standard Elizabeth School District report card. For purposes of promotion, retention, and grade point averages only the District report card will be used, however the International Baccalaureate requires the school to communicate standards based student achievement data with parents that the IBO has established.

#### **SECURITY**

Schools are committed to providing a safe and secure environment for all staff and students; therefore security/surveillance cameras, metal detectors and hand-held wands are used. All staff, students, and visitors must pass through a metal detector and submit to a general search upon entering the building. All visitors are required to sign in, show proper ID, secure a visitor's pass and report to the main office. Visitors are not allowed to move freely around the building without prior approval or without being escorted by a staff or faculty member. Lockers are the property of the Board and are subject to search when there is reasonable suspicion they contain items prohibited in school.

# **Attendance and Tardiness Policy**

Attendance and tardiness is strictly enforced. Failure to comply with stated guidelines will result in the student's removal from the school.

#### Attendance:

The following procedures are in place for monitoring student absence. If your child is absent for ten consecutive school days or absent intermittently fifteen days they will be transferred to their neighborhood school.

**ABSENCE** 

Day's 6-9 Phone calls from the school office/District will be made unless absence is reported.

Day 10 Attendance officer may visit home to review child's attendance status. A letter is sent home by administration notifying parents of the number of absences. Meeting with Attendance Task Force, parent, and child will be arranged. Parents may document extenuating circumstances at this time.

- Day 12 A letter will be sent home informing you that your child will lose his/her place at magnet school upon their fifteenth day of absence. The Attendance Task Force will update and review the case.
- Day 15 Child will be transferred to their neighborhood school.

#### Tardiness/ Early Dismissal

The following steps are in place for student tardiness and early dismissal. Please remember that students must report to school before 7:30 (K-8) and 8:20 (PK) a.m. and are considered tardy at 7:40 and 8:30 a.m. accordingly. Students arriving late due to bus complications will not be counted as tardy.

- Day 5 Phone call and/or letter will be sent out notifying parent/guardian as to the number of tardies and that student is in danger of losing his/her place at magnet school on day 15.
- Day 10 Meeting with Attendance Task Force, parent, and child will be arranged. Parents may document extenuating circumstances at this time. Attendance Task Force will review case and attendance pattern.
- Day 12 A letter will be sent home informing you that your child will lose his/her place at magnet school upon their fifteenth day of tardiness. The attendance officer may make a visit to your home to insure you understand your child must report to school on time or they will be transferred to their neighborhood school. The Attendance Task Force will update and review the case.
- Day 15 Child will be transferred to their neighborhood school.

Please understand that this policy is intended to give your child the benefit of our magnet program. Students who miss time from school are missing valuable school experience. If you have any questions regarding this policy, please do not hesitate to contact our guidance counselor.
